There exists great opportunity in this particular area outside of Carnival. As it stands there are currently 10 or so national, community and religious festivals inclusive of Divali, Phagwa, Paramin Parang and La Divina Pastora to name a few. Each of these have music, food, costuming, intellectual and creative offerings that are unique to Trinidad and Tobago. The opportunities to tap into these festivals to promote culture, music and Trinidad and Tobago are endless. In the same way that persons have created interest in Carnival the opportunity exists, perhaps, not on the same scale but with the correct business plan the possibilities are endless and beneficial to all stake holders.

As we stand here today, the global music industry is exploring and embracing new ways to monetize music consumption and enhance the capabilities of technological platforms. We must continue to keep abreast of these opportunities and ensure that we remain up-to-date to be able to navigate and succeed in the changing music industry.

In closing, I wish to congratulate MusicTT on the introduction of the RVRB Experience and commend them on all the initiatives they continue to execute to ensure that they drive the music industry and equip music professionals with the necessary tools required to be globally competitive.

Let me also convey my appreciation to all partner entities from the local and international private sector that have collaborated with MusicTT for this event: Kin Sound Studios, Koru Green, Digipreneur FM, Motif Music Services, Caribbean Ideas Synapse, New Fire Festival and Sound Diplomacy.
