Executive Summary

The Goods Declaration Module saw a **7.6% increase in activity** for the month of **August 2022** when compared to the previous month, with the total volume of Entries submitted to TTBizLink going from **10,487** to **11,285** declarations. Furthermore, there was a **21.6% increase** in the number of declarations submitted to TTBizLink when compared to **August 2021** – with **9,279** Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **August 2022** was **12.78 hours** per declaration. The average processing time of the previous month stood at 10.05 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$5.53 Bn** worth of goods entered Trinidad and Tobago in August 2022. The below table and chart gives further information on selectivity by value¹.

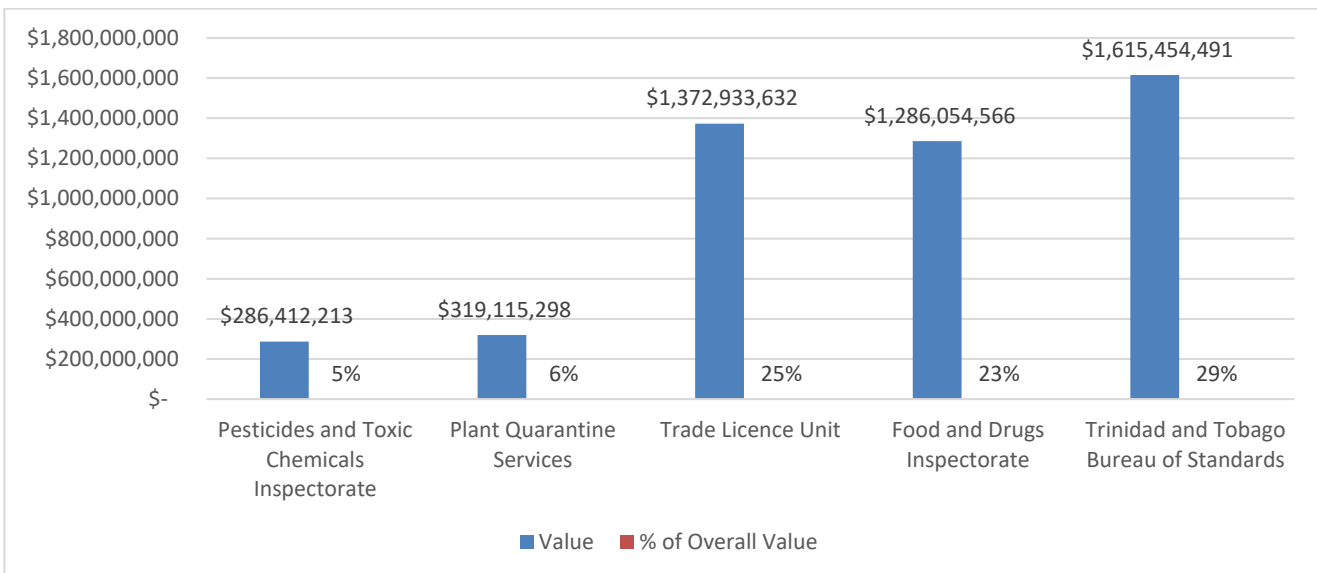
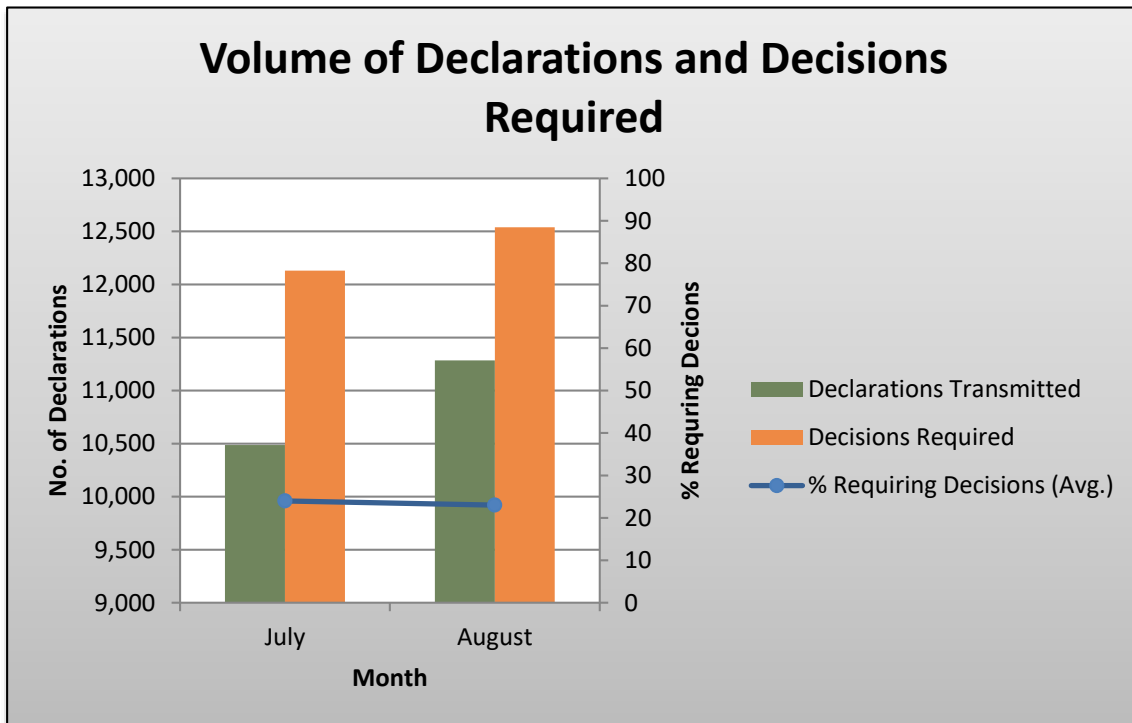


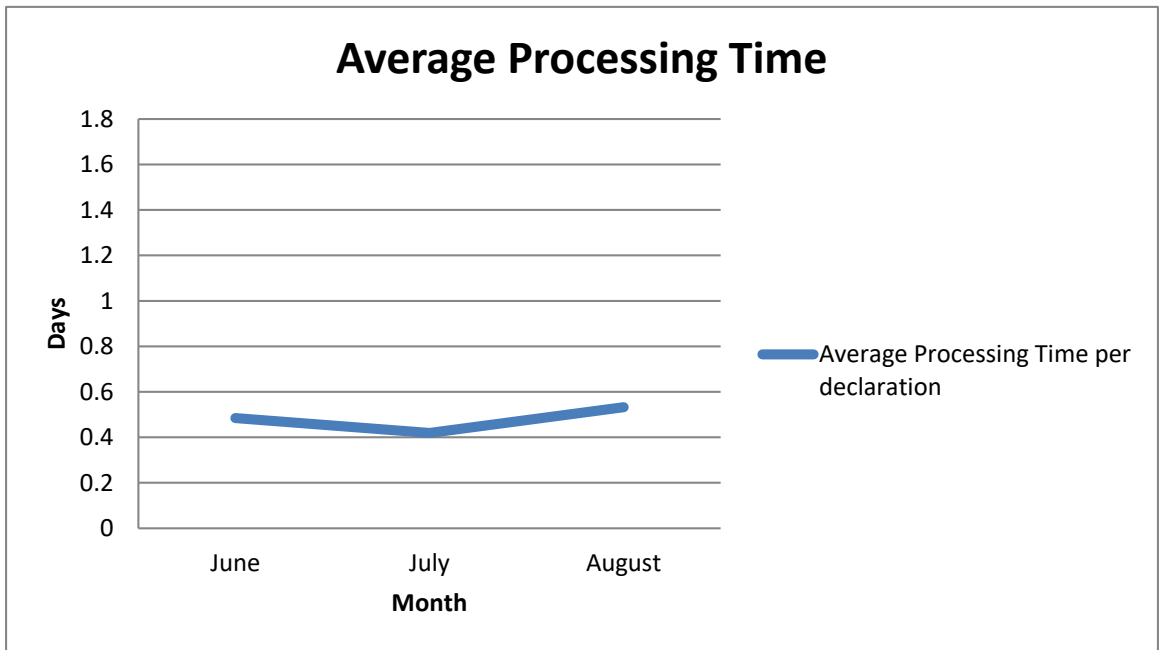
Table and Chart Demonstrating OGA Selectivity by Value
