### **Executive Summary**


The Goods Declaration Module saw a 22.3% decrease in activity for the month of December 2022 when compared to the previous month, with the total volume of Entries submitted to TTBizLink going from 12,570 to 9,772 declarations. Furthermore, there was a -12.1% decrease in the number of declarations submitted to TTBizLink when compared to December 2021 — with 11,118 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **December 2022** was **13.72 hours** per declaration. The average processing time of the previous month stood at 16.25 hours per declaration.

## TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.96 Bn** worth of goods entered Trinidad and Tobago in December 2022. The below table and chart gives further information on selectivity by value<sup>1</sup>.





