Executive Summary

The Goods Declaration Module saw a **6.8% increase in activity** for the month of **January 2023** when compared to the previous month, with the total volume of Entries submitted to TTBizLink going from **9,772** to **10,440** declarations. Furthermore, there was a **16.4% increase** in the number of declarations submitted to TTBizLink when compared to **January 2022** – with **8,973** Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **January 2023** was **13.69 hours** per declaration. The average processing time of the previous month stood at 13.72 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.72 Bn** worth of goods entered Trinidad and Tobago in January 2023.






Table and Chart Demonstrating OGA Selectivity by Value
