Executive Summary

The Goods Declaration Module saw a **2.2% decrease in activity** for the month of **September 2022** when compared to the previous month, with the total volume of Entries submitted to TTBizLink going from **11,285** to **11,037** declarations. Furthermore, there was a **3.3% decrease** in the number of declarations submitted to TTBizLink when compared to **September 2021** – with **11416** Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **September 2022** was **10.95 hours** per declaration. The average processing time of the previous month stood at 12.78 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$6.24 Bn** worth of goods entered Trinidad and Tobago in September 2022. The below table and chart gives further information on selectivity by value¹.

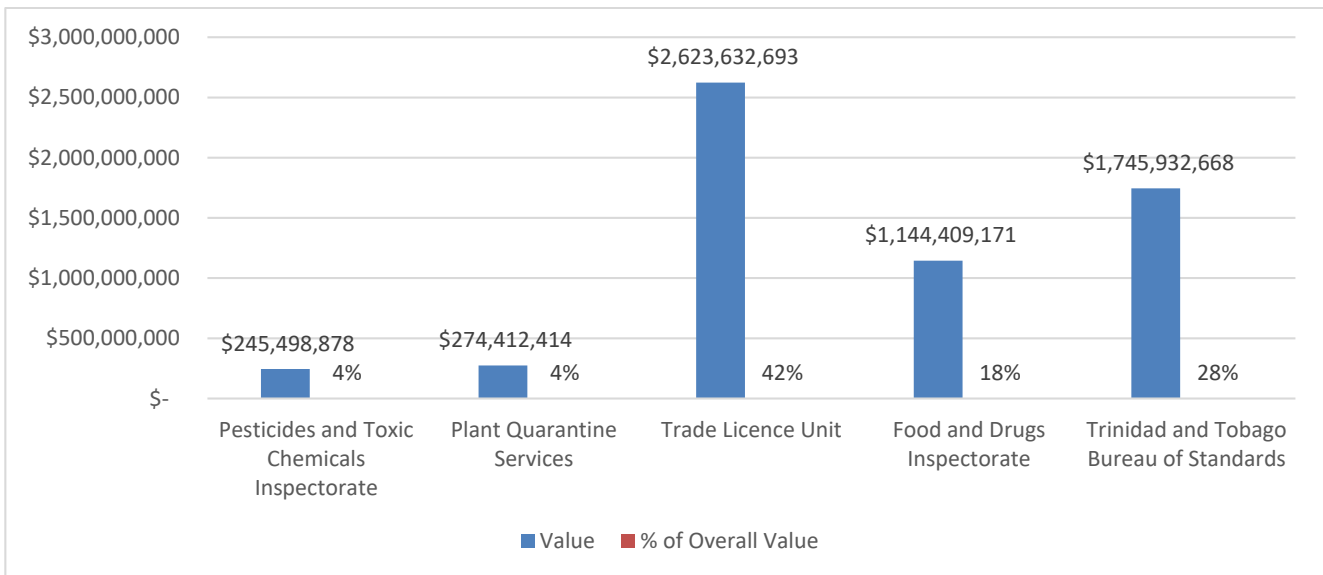
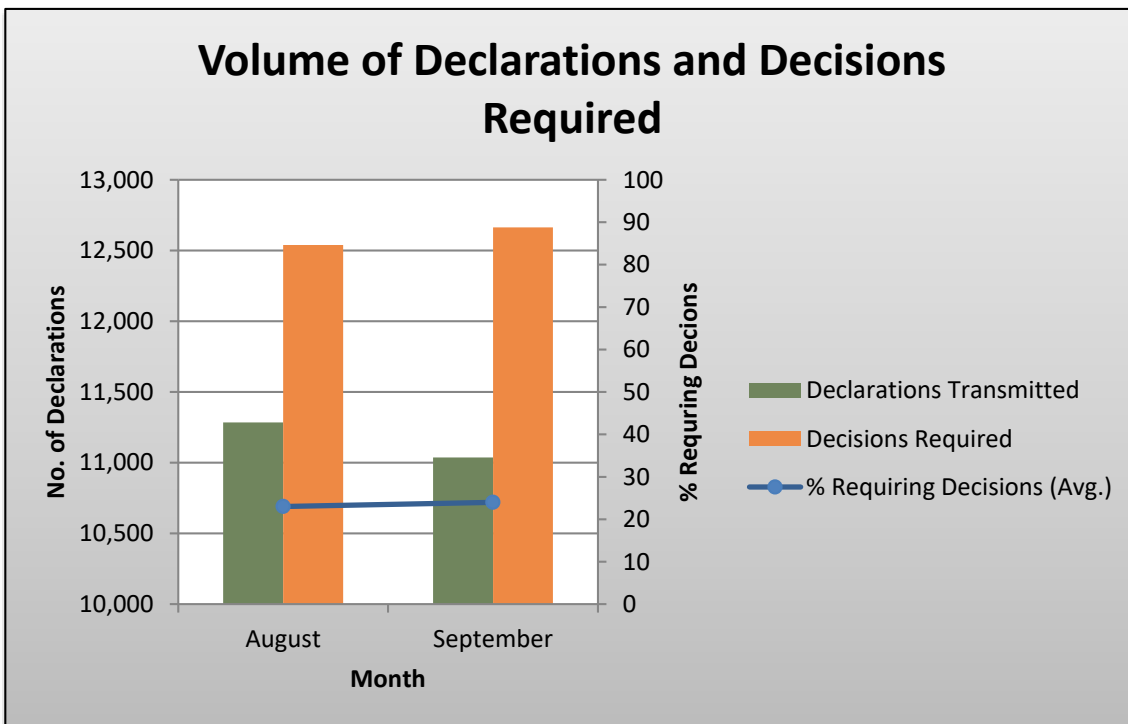


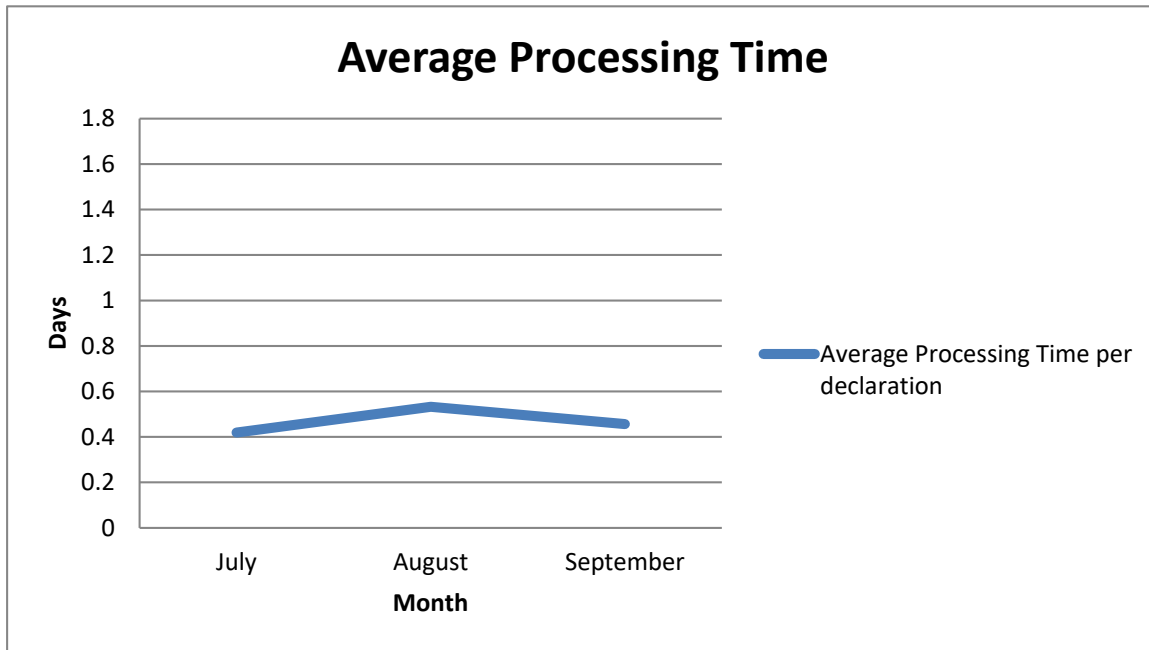
Table and Chart Demonstrating OGA Selectivity by Value
