Executive Summary

The Goods Declaration Module saw a **11% decrease in activity** for the month of **June 2023** when compared to the previous month, with the total volume of Entries submitted to TTBizLink going from **11,473 to 10,209** declarations. Furthermore, there was an **10.2% increase** in the number of declarations submitted to TTBizLink when compared to **June 2022** – with 9,264 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **June 2023** was **14.77 hours** per declaration. The average processing time of the previous month stood at 12.95 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$4.13 Bn** worth of goods entered Trinidad and Tobago in June 2023. The below table and chart gives further information on selectivity by value¹.






Table and Chart Demonstrating OGA Selectivity by Value
