Executive Summary

The Goods Declaration Module saw a **0.8% decrease in activity** for the month of **September 2023** when compared to the previous month, with the total volume of Entries submitted to TTBizLink going from **11,121 to 11,027** declarations. Furthermore, there was an **0.09% decrease** in the number of declarations submitted to TTBizLink when compared to **September 2022** – with 11,037 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **September 2023** was **21.77 hours** per declaration. The average processing time of the previous month stood at 20.63 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$8.22 Bn** worth of goods entered Trinidad and Tobago in September 2023. The below table and chart gives further information on selectivity by value¹.

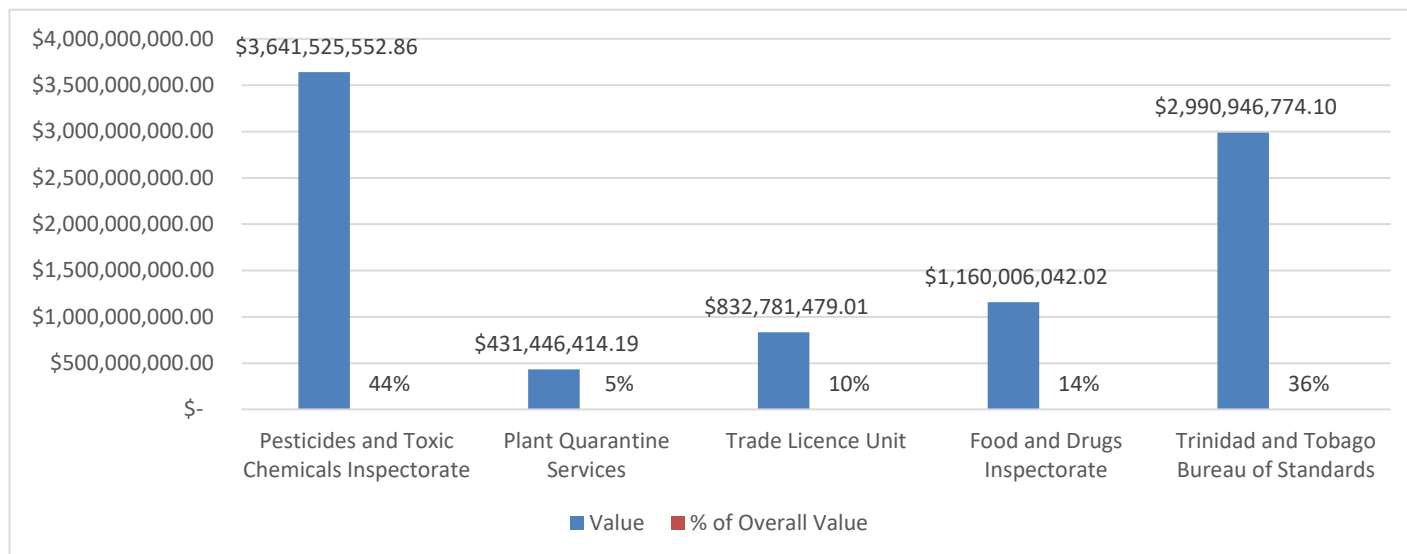
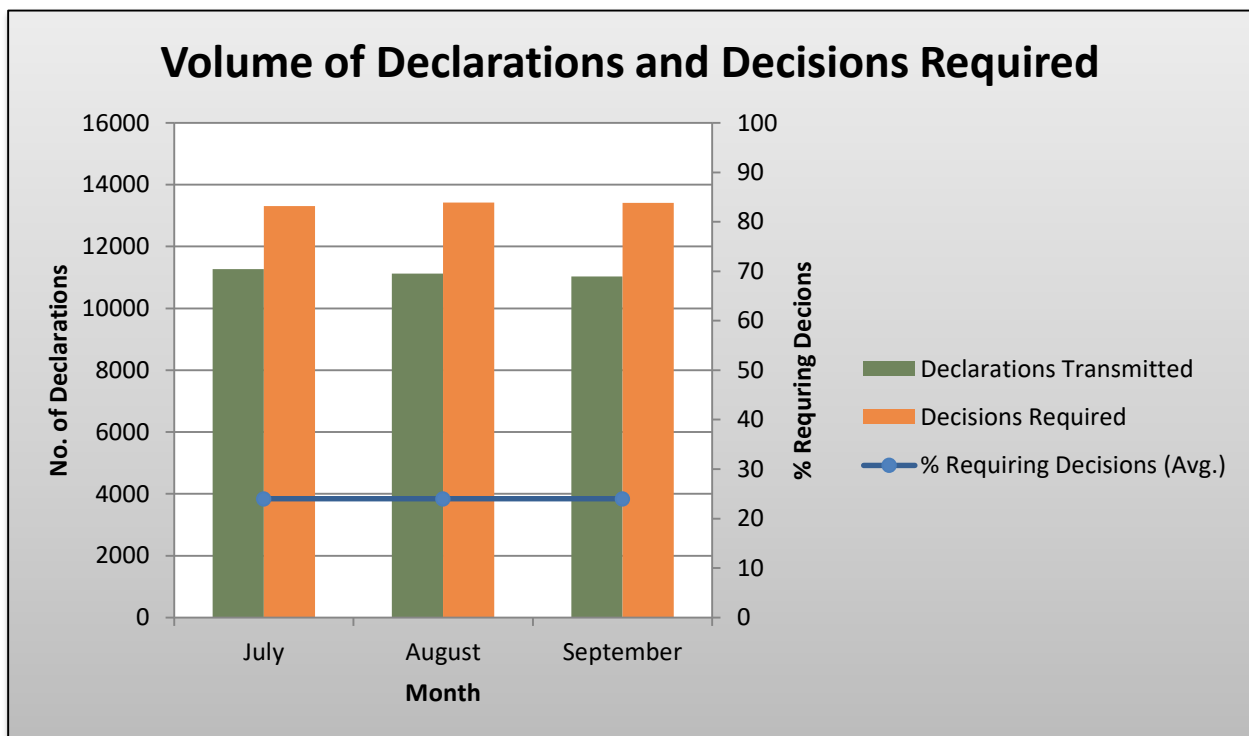


Table and Chart Demonstrating OGA Selectivity by Value

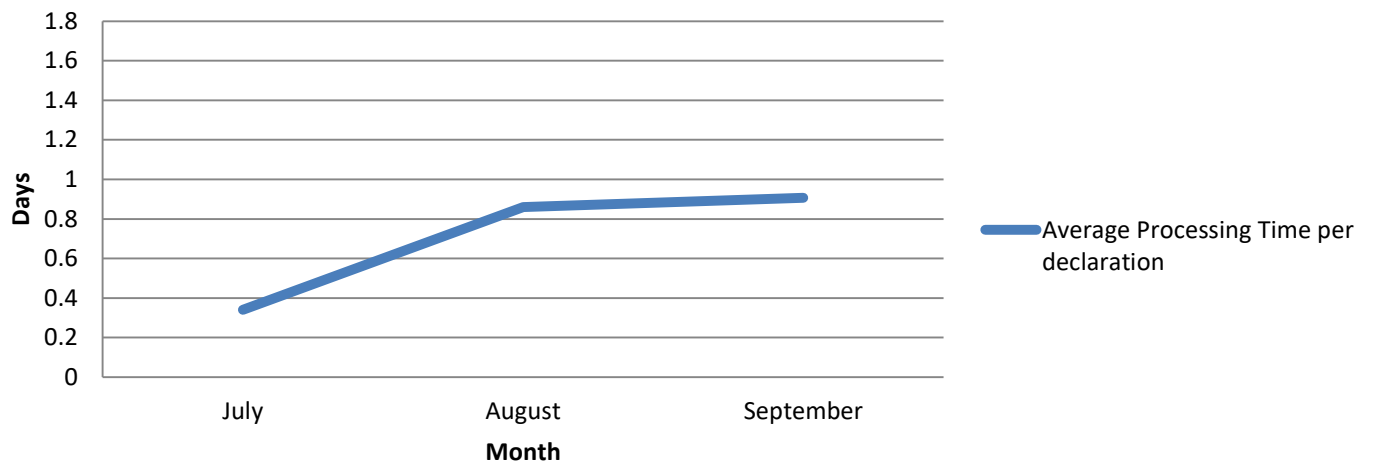
