#### **Executive Summary**

The Goods Declaration Module saw a **14.3% increase in activity** for the month of **April 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **10,241 to 11,702** declarations. Furthermore, there was an **17.85% increase** in the number of declarations submitted to TTBizLink when compared to **April 2023** – with 9,930 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **April 2024** was **11.56 hours** per declaration. The average processing time of the previous month stood at 13.98 hours per declaration.

### TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$10.67 Bn** worth of goods entered Trinidad and Tobago in April 2024. When compared to the previous month, the total value of declarations was TT\$3.87 Bn. This increase is due to one importer bringing in \$6,329,487,382.44 worth of goods in April 2024 where the declarations for these goods were routed for PTCI selectivity and some for TTBS selectivity. This is reflected in this month's spike in values for these two agencies.




