Executive Summary

The Goods Declaration Module saw a **6% decrease in activity** for the month of **May 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **11,702 to 11,002** declarations. Furthermore, there was an **4.11% decrease** in the number of declarations submitted to TTBizLink when compared to **May 2023** – with 11473 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **May 2024** was **14.05 hours** per declaration. The average processing time of the previous month stood at 11.56 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$5.97 Bn** worth of goods entered Trinidad and Tobago in May 2024.

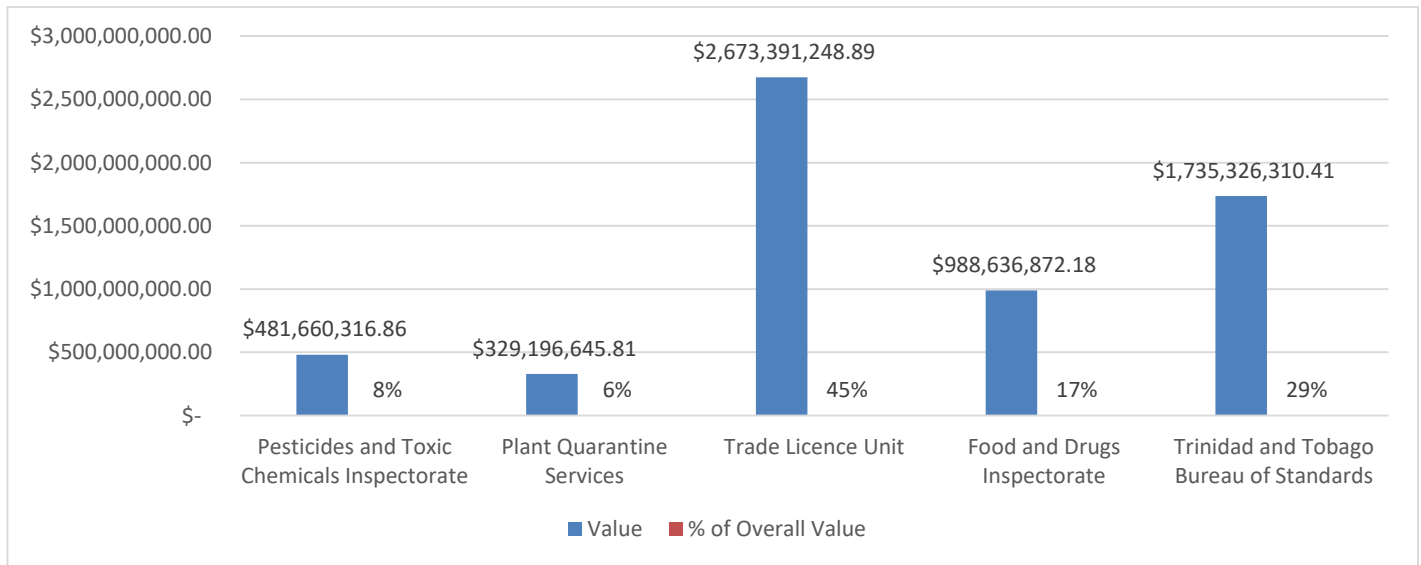
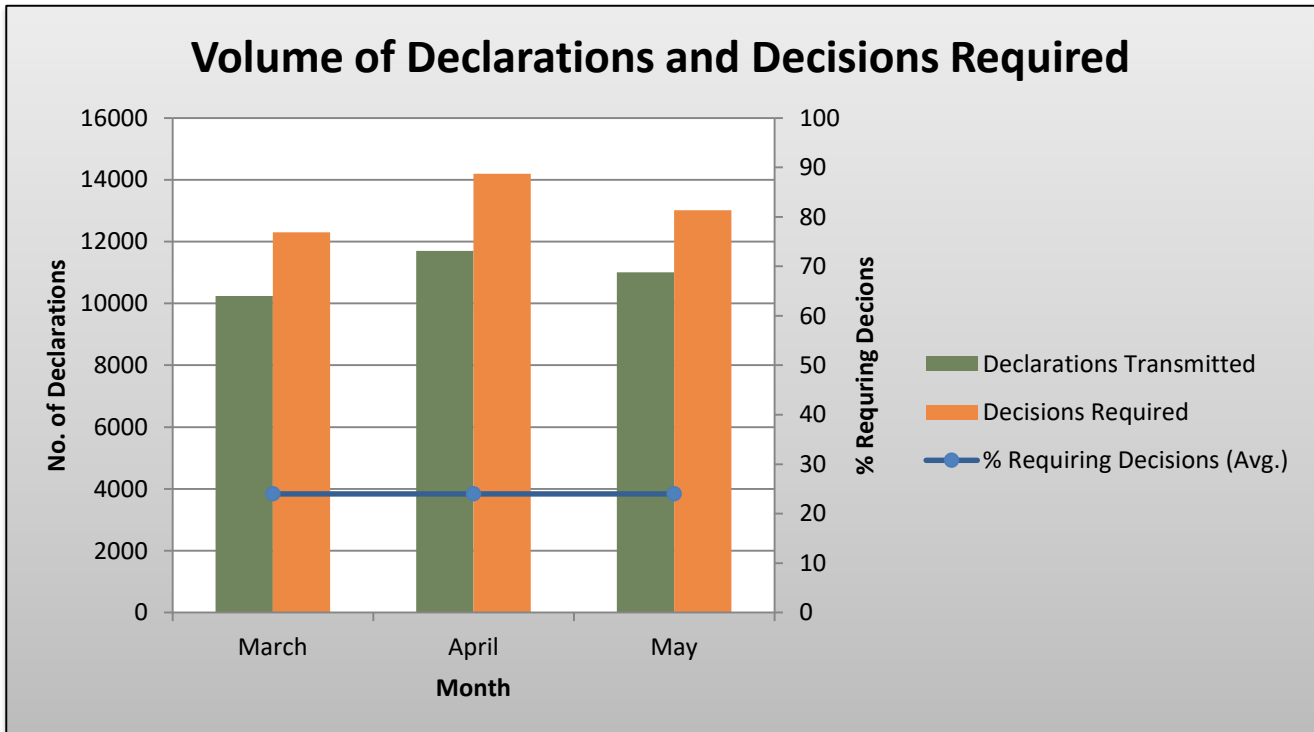


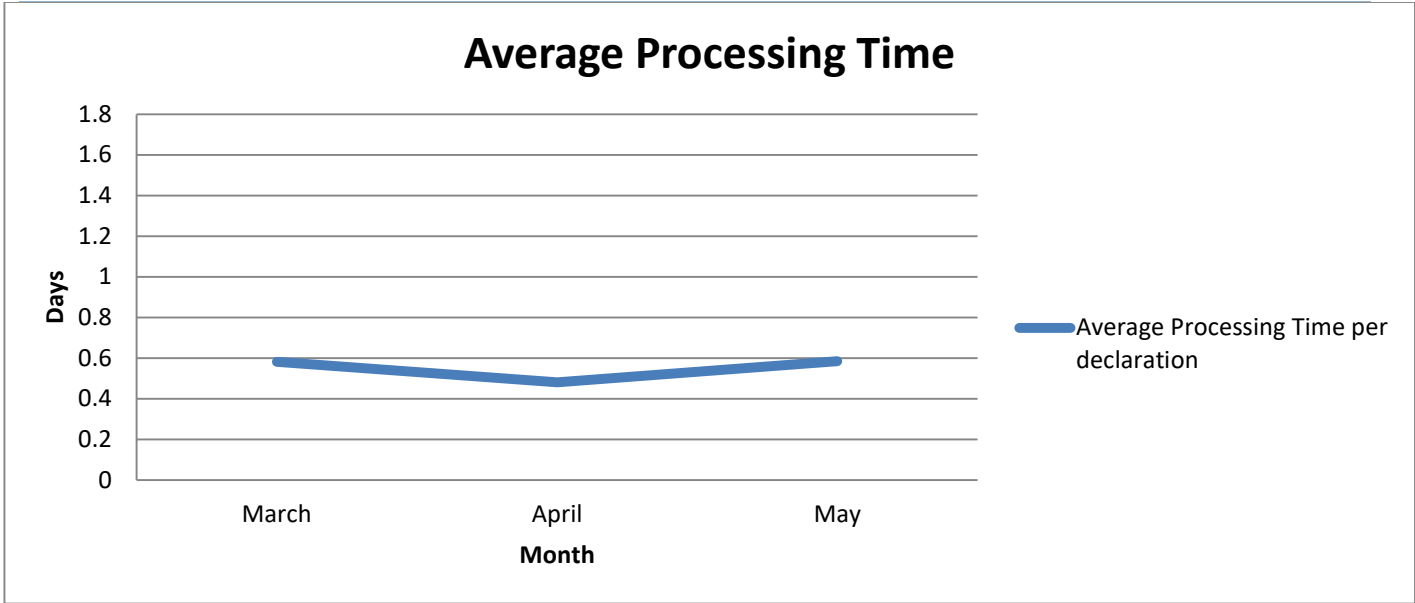
