In order to be considered registered, suppliers and service providers are required to complete forms REG-01, REG-02 and REG-03. All forms are to be completed in English, and must be submitted with the following supporting documents:

• Certificate of Registration, Incorporation or Continuance (as applicable)

The registration forms must be addressed to the Permanent Secretary of the Ministry of Trade and Industry. Completed forms together with the supporting information must be submitted to MTI-Registration@gov.tt.

The MTI will review the forms submitted and may seek clarification as needed to complete the registration process.
