Non-Energy Manufacturing and Exports

The Ministry of Trade and Industry (MTI) continues to work assiduously to grow and diversify our non-energy manufacturing sector. Over the last four years, from 2020 to 2023, exports of the non-energy manufacturing sector increased by approximately TT\$1.9 billion. Considering that this period was challenging for businesses not just domestically, but globally, this growth underscores the sector's strength and resilience. In 2023, according to provisional data by the Central Statistical Office, the MTI estimated that non-energy manufacturing exports were approximately TT\$12.8 billion,

representing an estimated 96% of total non-energy exports and 25% of total exports.

Food and Beverage Subsector

CDC is classified under the food and beverage subsector within the manufacturing sector. This subsector is the second largest by export value, and has maintained this export position over the period 2020 to 2023. During this time, the food and beverage subsector grew by 35%, from TT\$2.3 billion in exports in 2020 to TT\$3.1 billion in 2023. This performance is a testament to the sub-sector's vitality and potential.

We must commend Carib for its noteworthy contributions to this performance. Over the last four years, locally produced beer remained among the top exported commodities from the food and beverage subsector.

With expansions and technological upgrades such as this, strategic partnerships, and your formidable export shrewdness, CDC is on the right path to solidifying a local brand in the global arena and contributing to our economy's export diversification agenda. In fact, the recent announcement by ANSA McAL in establishing a joint venture to propel its brand into an Asian market exemplifies the forward-thinking strategies that will drive Trinidad and Tobago's success.

Trade Missions

The MTI remains committed to paving the way for domestic companies to capitalize on international opportunities. The successful execution of trade missions plays a pivotal role in this, boosting visibility of existing exporting companies and creating potential partners and buyers in targeted markets.

CDC undoubtedly continues to bring energy and vibrancy into the domestic manufacturing sector and the economy, serving as a beacon of inspiration to others.
