Executive Summary

The Goods Declaration Module saw a **1.9% decrease in activity** for the month of **August 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **11,916 to 11,692** declarations. Furthermore, there was an **5.13% increase** in the number of declarations submitted to TTBizLink when compared to **August 2023** – with 11,121 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **August 2024** was **16.25 hours** per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$4.41 Bn** worth of goods entered Trinidad and Tobago in August 2024.

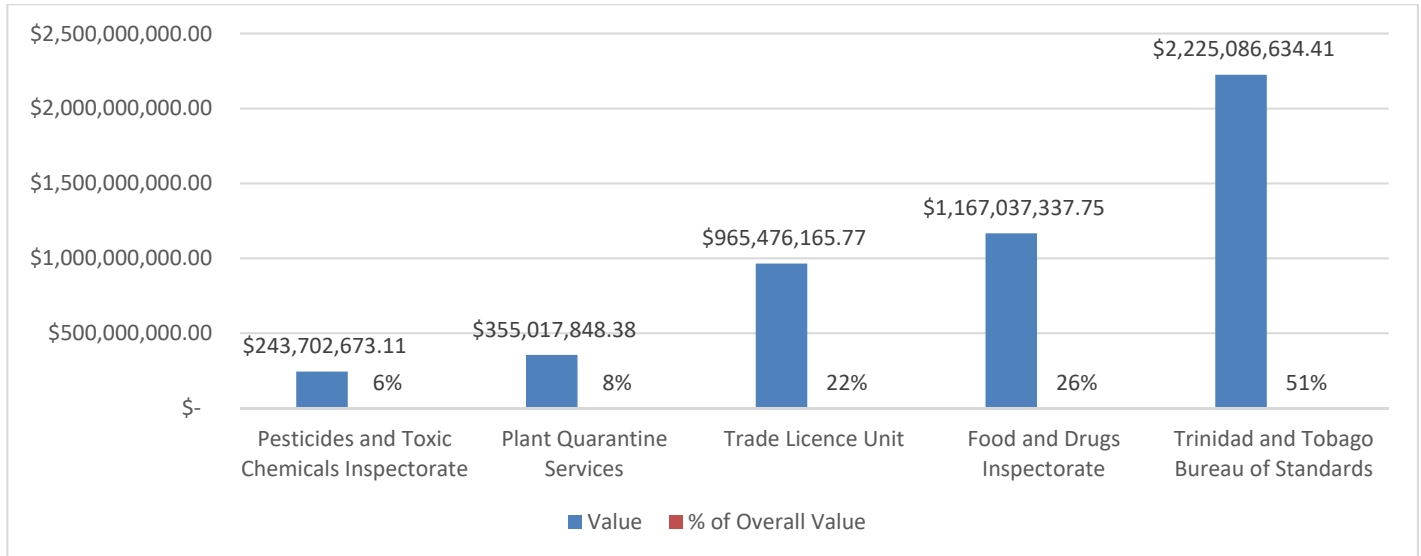
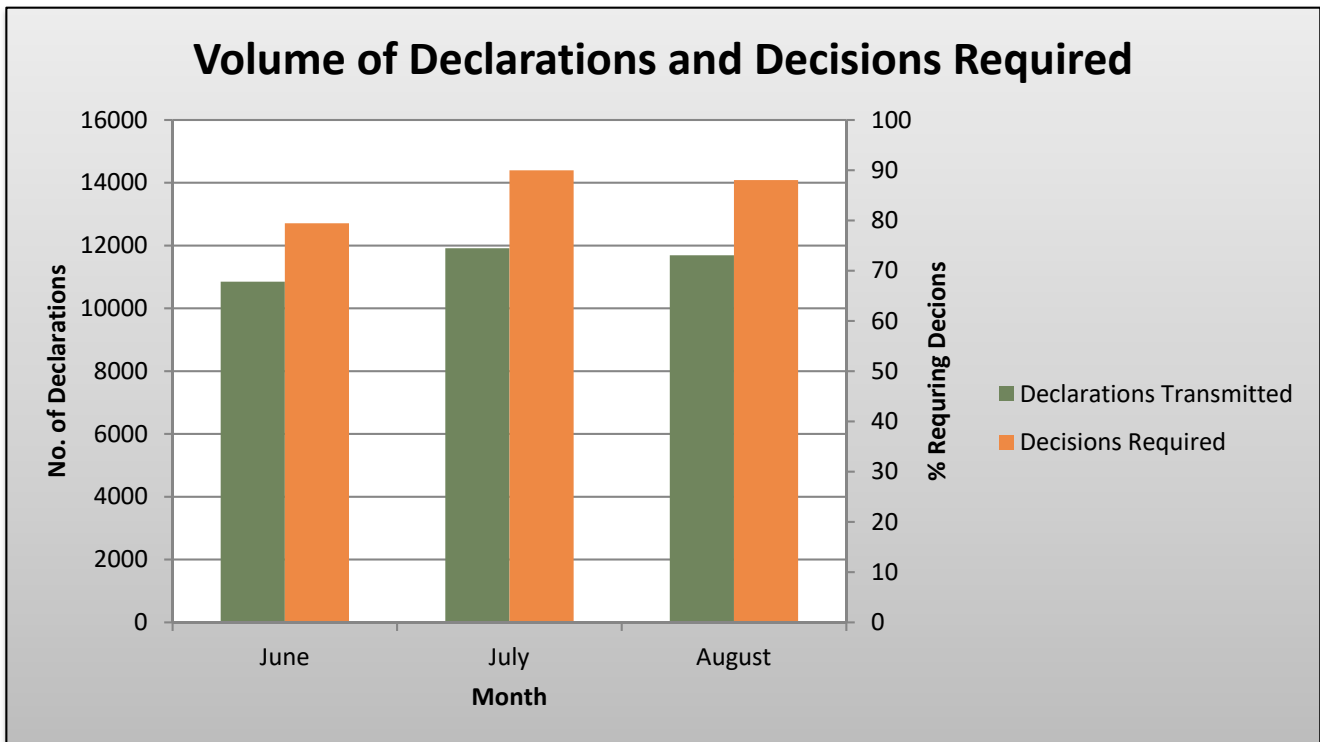


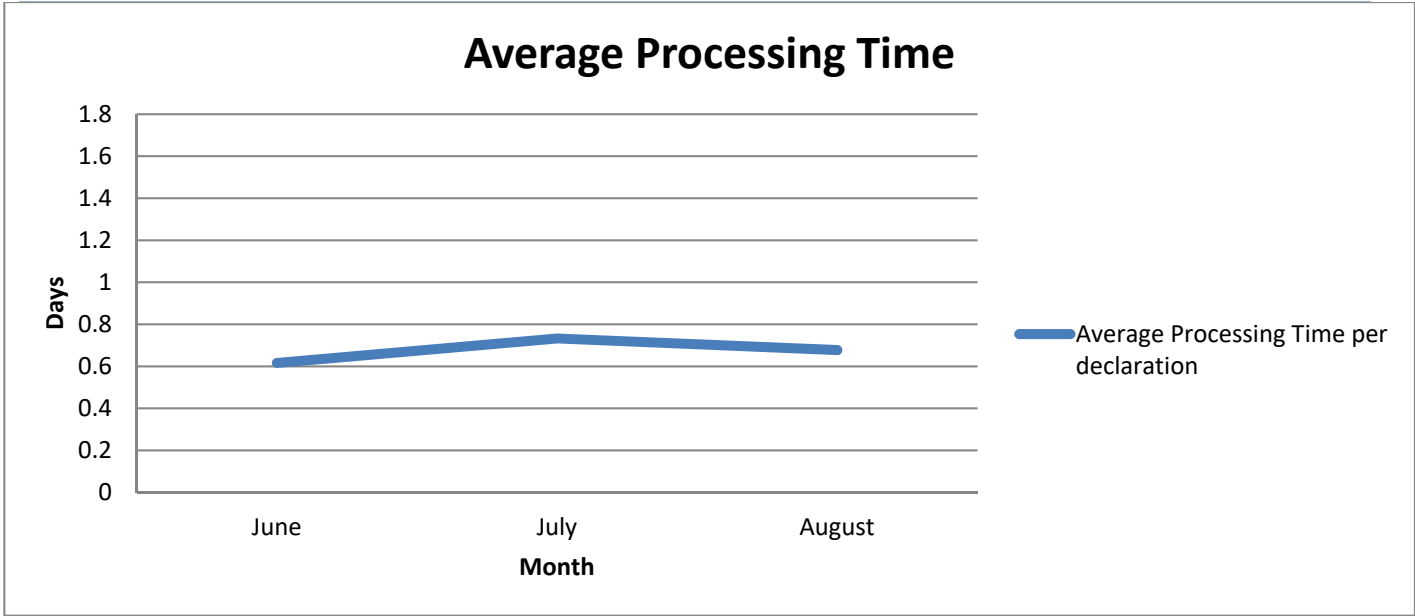
