Executive Summary

The Goods Declaration Module saw a **9.9% increase in activity** for the month of **July 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **10,847 to 11,916** declarations. Furthermore, there was an **5.74% increase** in the number of declarations submitted to TTBizLink when compared to **July 2023** – with 11,269 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **July 2024** was **17.6 hours** per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$4.51 Bn** worth of goods entered Trinidad and Tobago in July 2024.

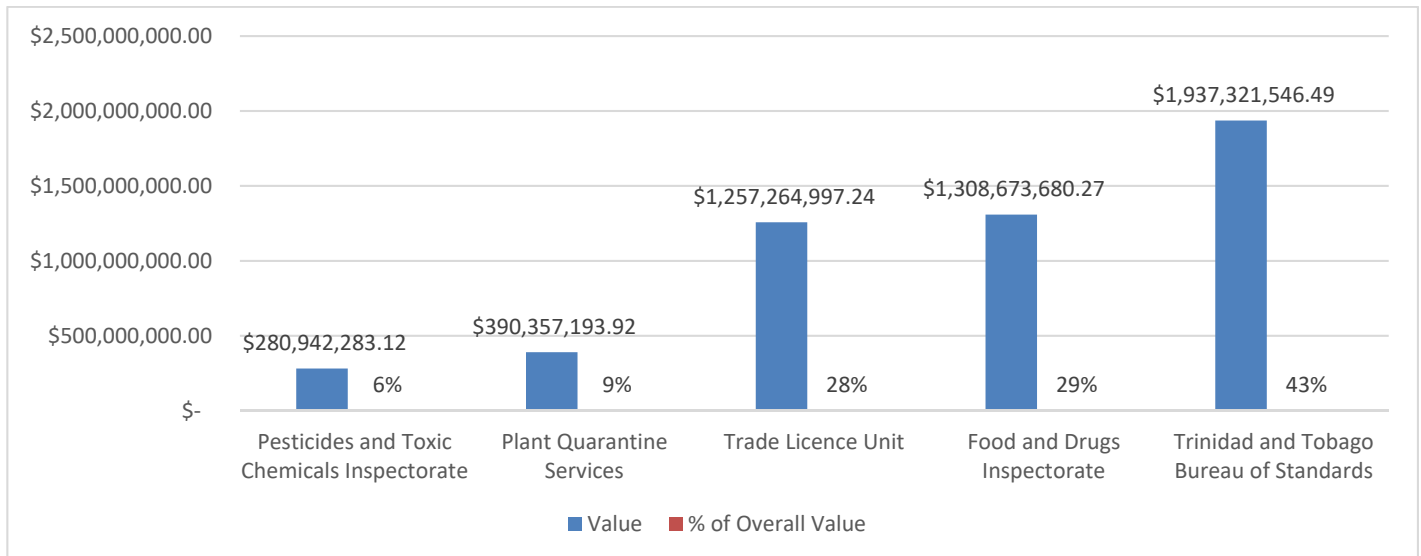
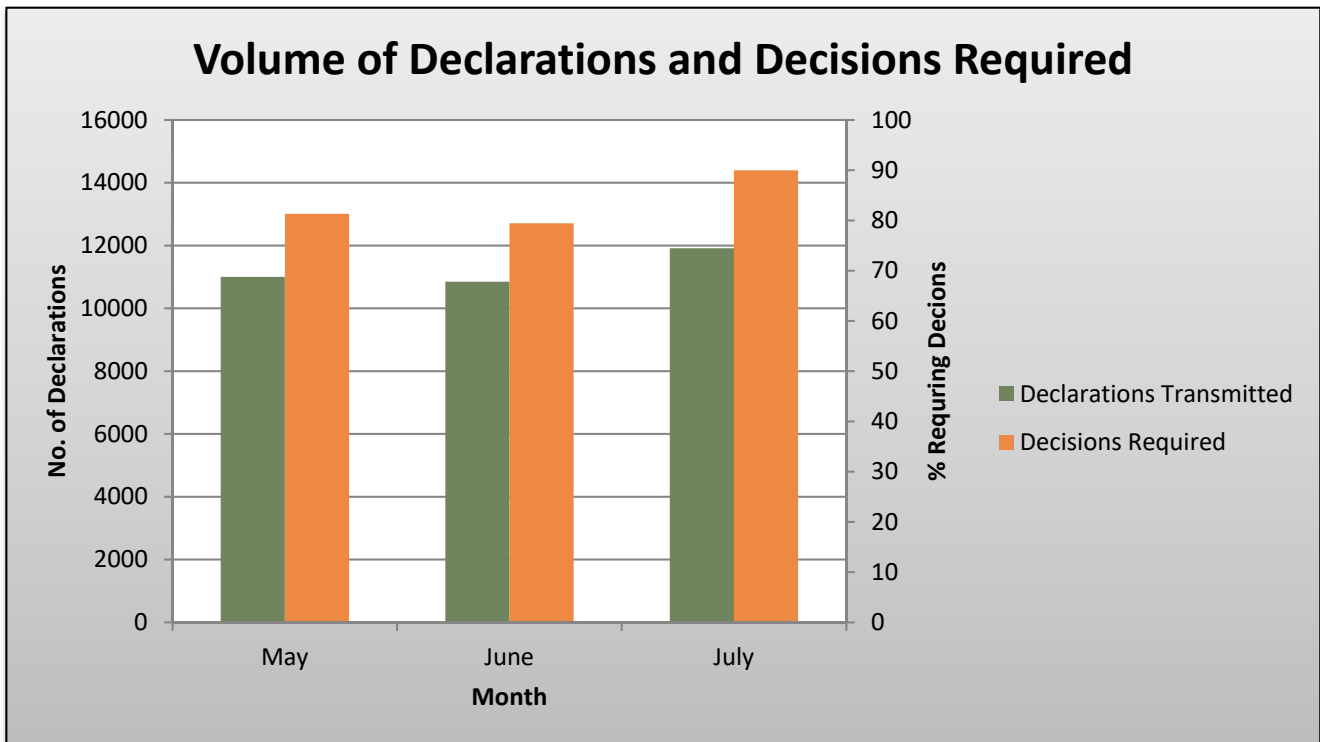


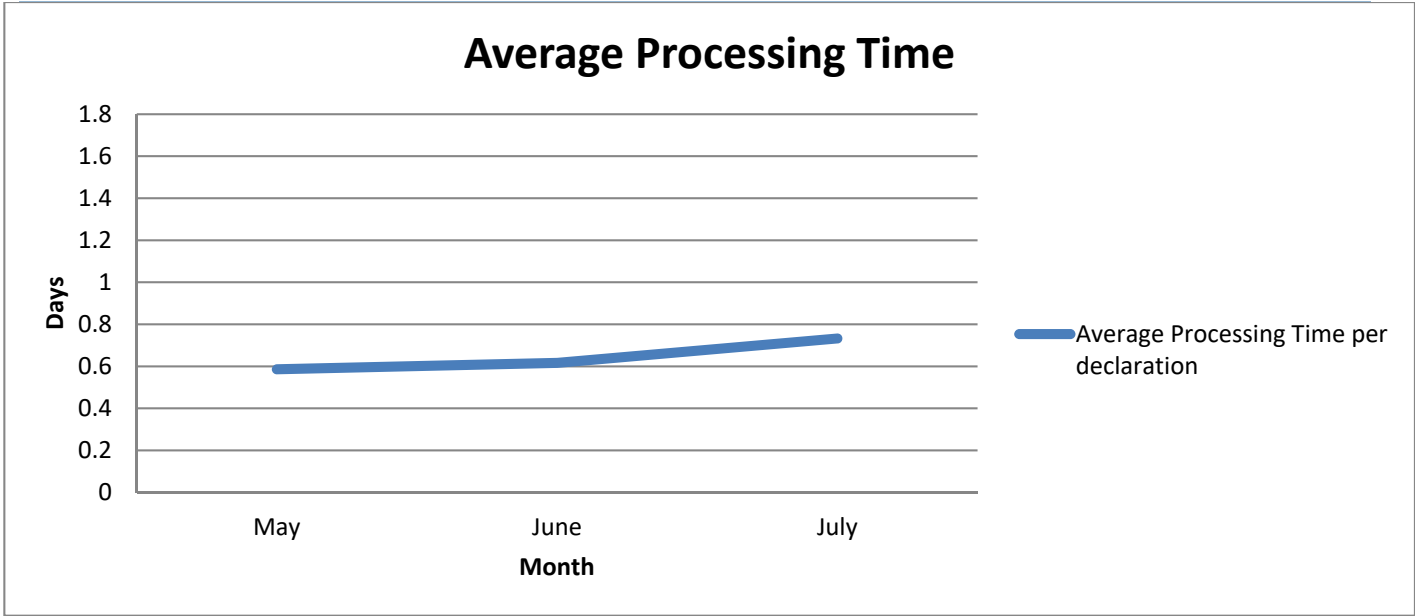
