Executive Summary

The Goods Declaration Module saw a **1.4% decrease in activity** for the month of **June 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **11,003 to 10,847** declarations. Furthermore, there was an **6.25% increase** in the number of declarations submitted to TTBizLink when compared to **June 2023** – with 10,209 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **June 2024** was **14.79 hours** per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$4.95 Bn** worth of goods entered Trinidad and Tobago in June 2024.

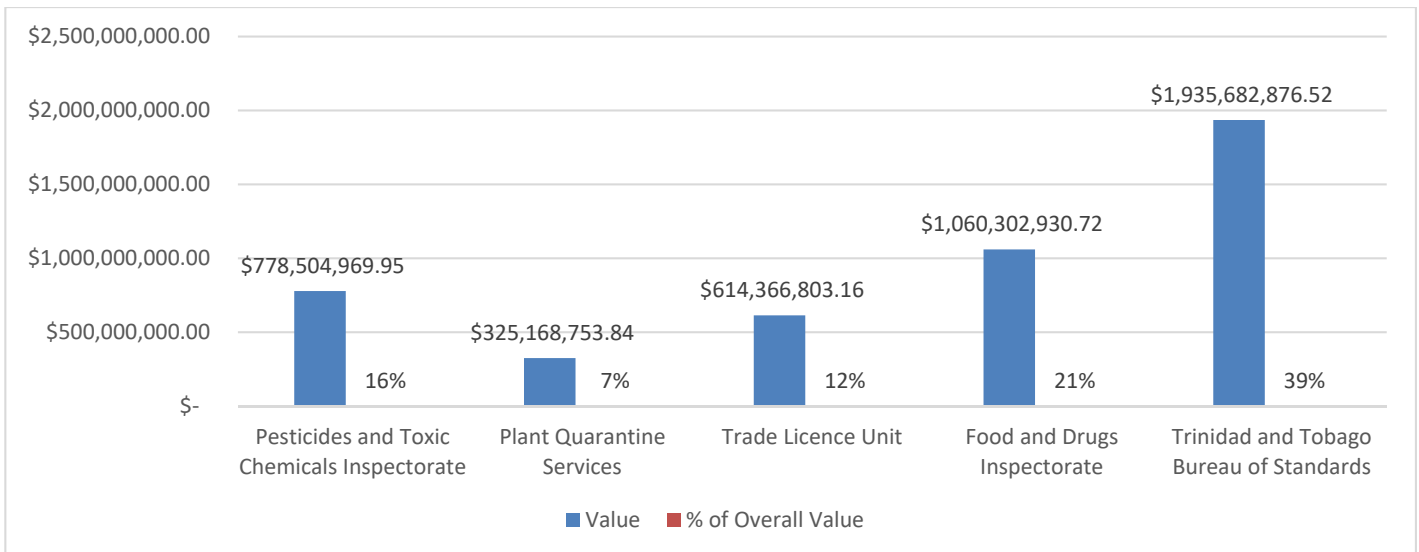
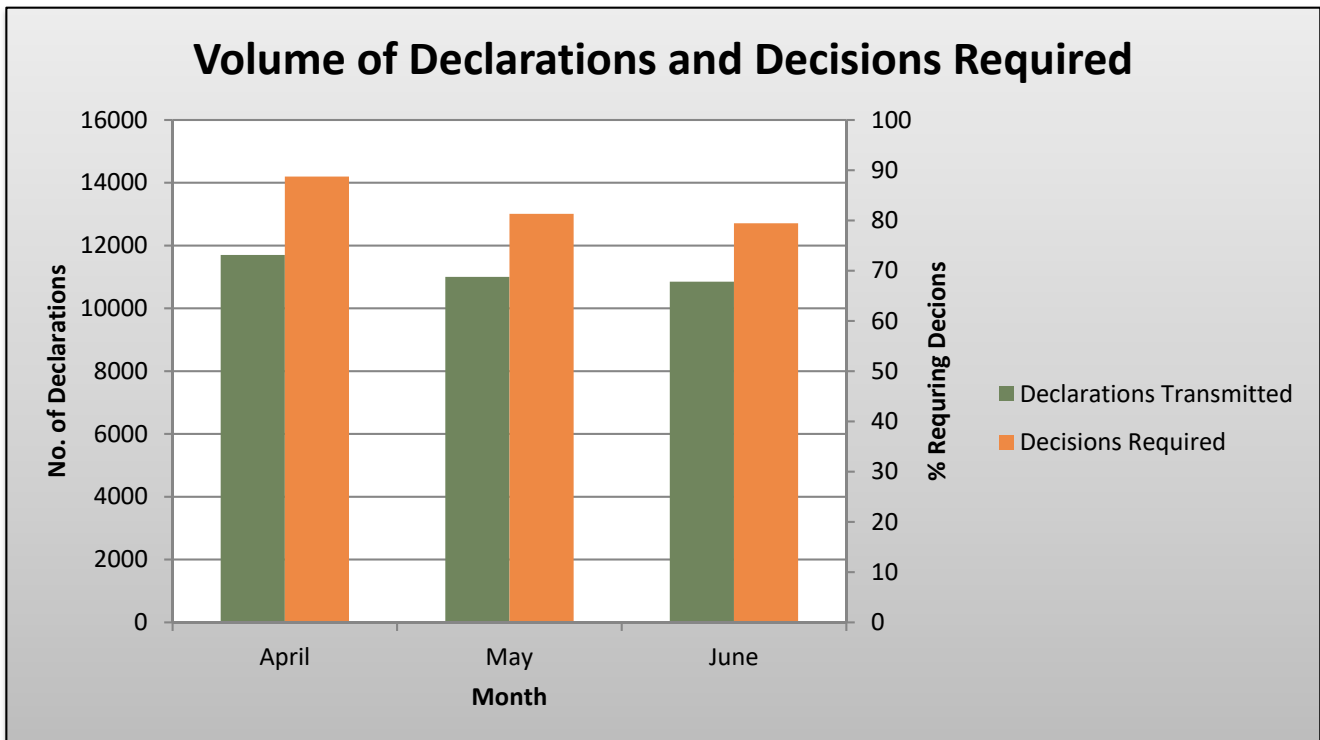


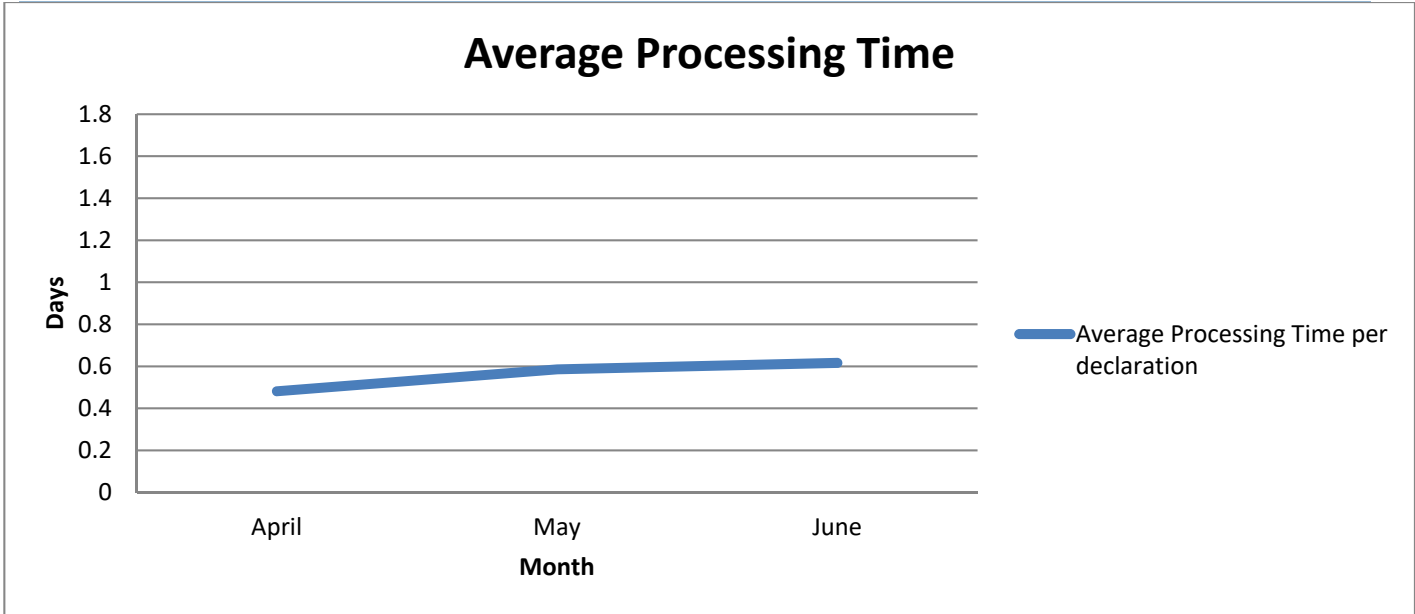
