THE MANDATE OF EXPORTT

Ladies and gentlemen, having been designated the National Export Facilitation Organization, exporTT bears substantial responsibility for export growth and diversification, the increased competitiveness of exporters, the development of new exporters, and the expansion into new markets. These activities must be informed by market research and intelligence.

It calls for the forging of close working relationships with both export ready companies and those exhibiting export potential. There is firm belief that the work of exporTT can create a concerted and sustained export drive leading to increased foreign exchange earnings, however, such a drive can only be achieved if all the partners in the export schematic recognize their role and work together.

In this regard, the Ministry of Trade and Industry continues to engage stakeholders in the development of Trinidad and Tobago's trade policy supported by exporTT. This relationship has deepened and is better defined with the outputs of the company now fully incorporated into the development of the Ministry's annual work-plan.
