Angostura has the distinction of being a Royal Warrant holder to the Queen of England and has achieved BSI's ISO 9002-2008 certification for quality standards and the environmental management standards ISO 14001-2004 certification. It is also BSI certified for Food Safety Systems FSSC 22000. Its Laboratory also received accreditation for chemical testing from the Trinidad and Tobago Laboratory Accreditation Service, the first manufacturing company in the region to obtain such an accreditation. This is truly remarkable!

The company's ability to be internationally competitive also aligns with the Government's role in ensuring local manufacturers' competitiveness on the global stage.

In 2018 Angostura Limited was the 4th largest non-energy exporter globally of aromatic bitters, rums and liqueurs and cordials. The company provides a model for local manufacturers in satisfying and exceeding the standards required to supply one hundred and seventy (170) diverse markets.

The Government is desirous of having this model replicated and through exporTT, provides support, to all exporters seeking to implement international standards required for entry into export markets. These include, but are not limited to Good Manufacturing Practices (GMP), Hazard and Hazards and Critical Control Points Management (HACCP), and Compliance with the US Food Safety Modernization Act (FSMA).

Hopefully in the coming years we can have other local businesses which like Angostura penetrate varied markets in the United States, Australia, Canada, Nertherlands, United Kingdom, Barbados and Saint Lucia to name a few.

Ladies and gentlemen as I close, it is my firm belief that the spirit of entrepreneurship, guided by exemplary leadership demonstrated by Angostura has paved the way for others to follow. And while we are here to commemorate the good works of an enterprise that is socially and environmentally aware we must also commend the contributions of the civic minded individuals who are also being celebrated this evening.
