Executive Summary

The Goods Declaration Module saw a **10% increase in activity** for the month of September 2020, with the total declarations submitted to TTBizLink going from **10,997** to **12,191** declarations.

The average processing time was 13.13 hours (0.55 days) per declaration, up from the previous month (10.76 hours)

There were no incidents raised during the month of September.

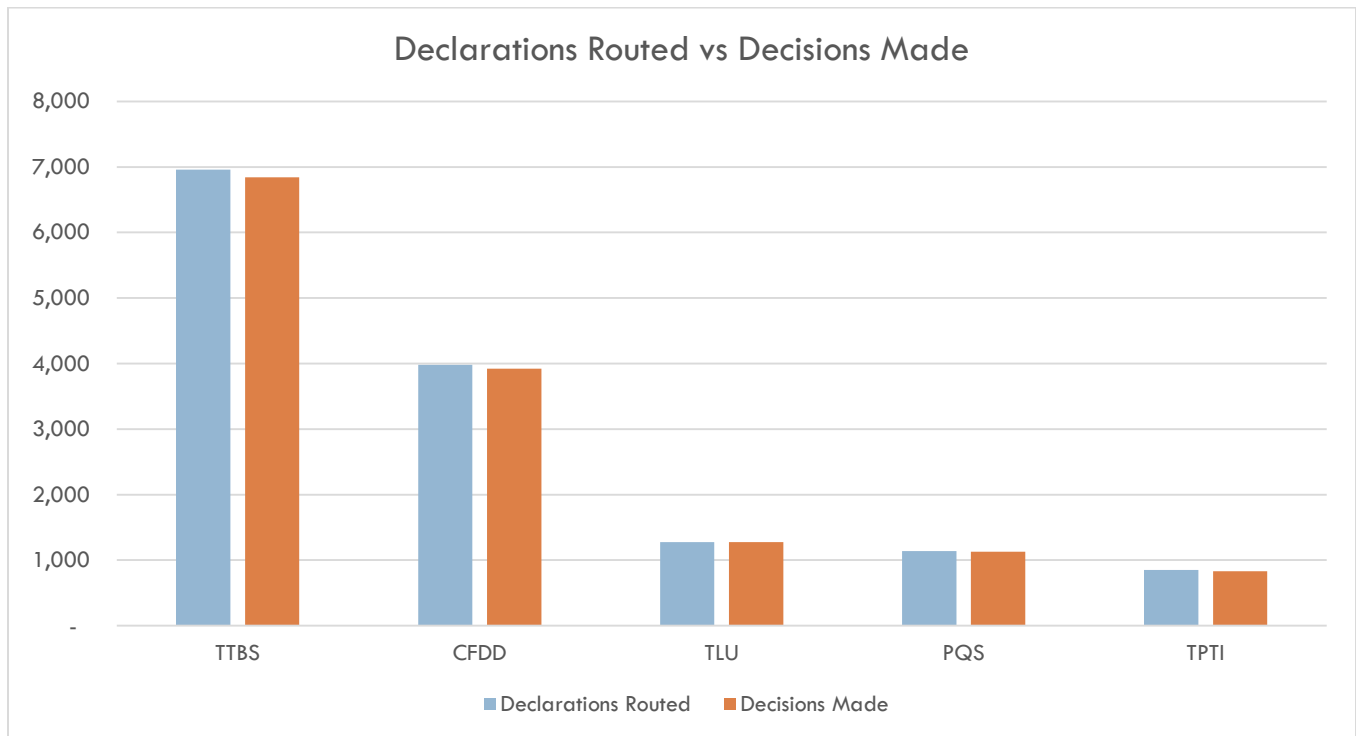
There were no change orders raised during the month of September.

Volume of Declarations Routed to Each Agency

TTBS received the most declarations (6,961) for processing and also made the most decisions (6841) in September 2020. By contrast, PTCI received 852 of the 12,191 declarations and made 830 decisions.

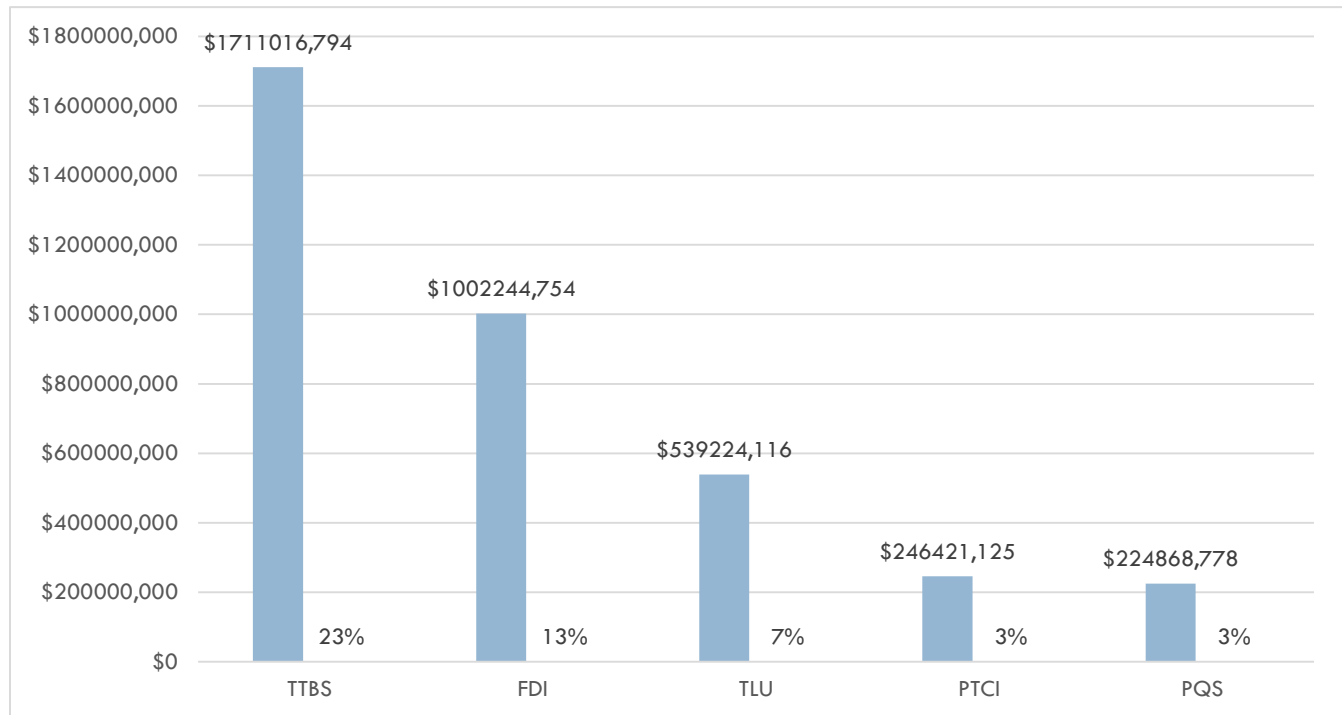
TT\$ Value of Declarations Routed to Each Agency

A combined **TT\$ 7.5 Bn** worth of goods entered Trinidad and Tobago in September 2020, as one of: Imports, Temporary Imports, Re-Imports, Entry for Warehousing and Other Import Procedures. Of this, TT\$ 32.8 Mn worth of goods were selected for inspection, representing 0.43%

Roughly 23% of goods, by value, were routed to TTBS. Of this, 0.014% were selected for inspection.

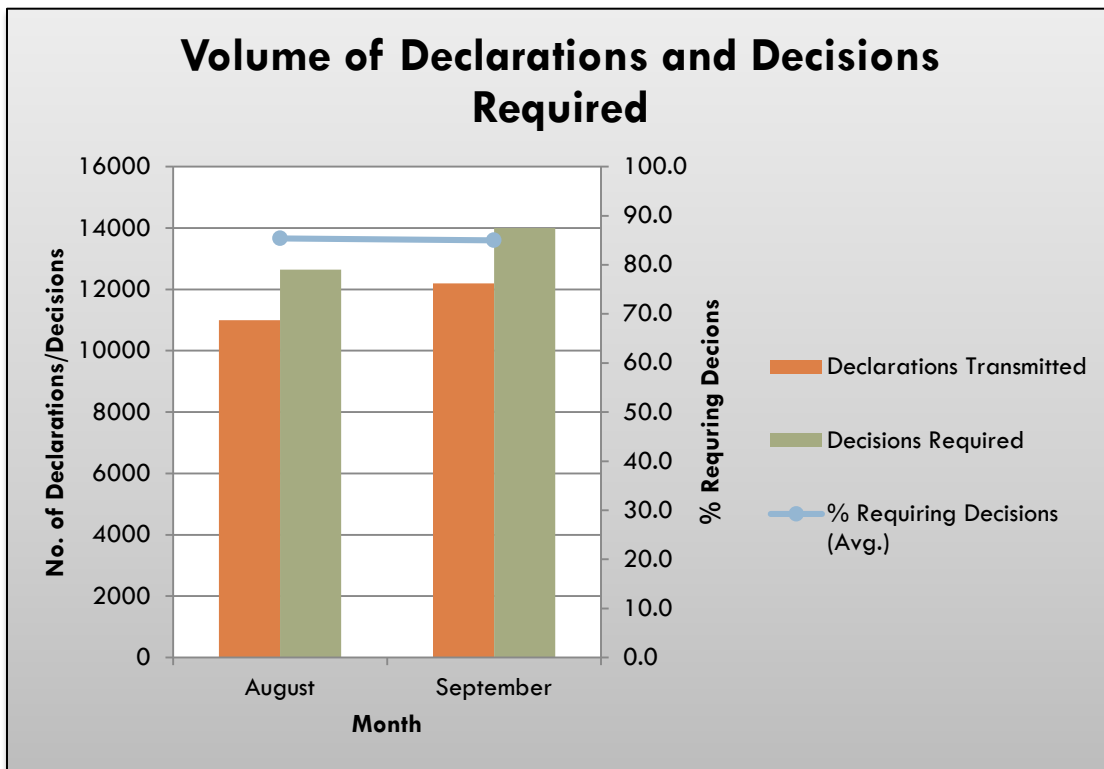

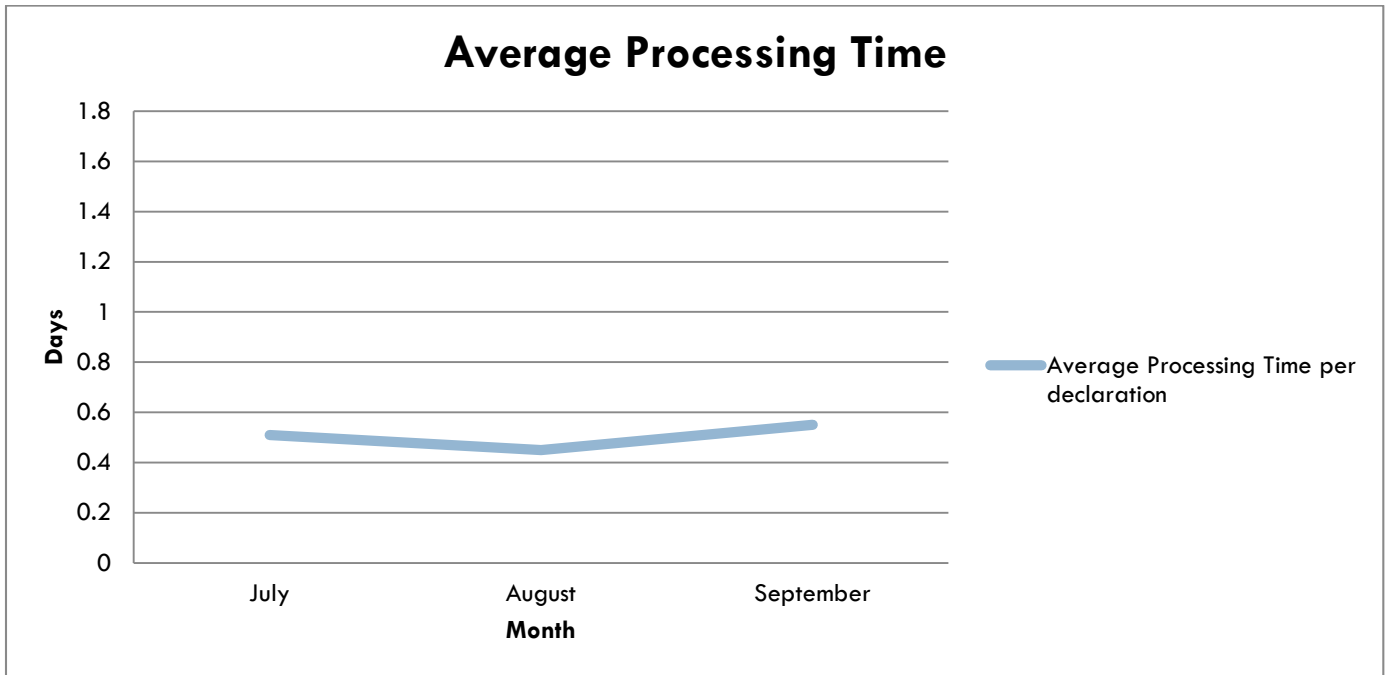
