#### **Executive Summary**


The Goods Declaration Module saw a 23% increase in activity for the month of September 2021 when compared to the previous month, with the total declarations submitted to TTBizLink going from 9,279 to 11,416 declarations. Furthermore, there was a 6.4% decrease in the number of declarations submitted to TTBizLink when compared to September 2020 – where 12,191 declarations were routed to TTBizLink during that month.

The average processing time among OGAs in **September 2021** was **3.97 hours** per declaration. The average processing time of the previous month stood at 3.03 hours per declaration.

### TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$6.8 Bn** worth of goods entered Trinidad and Tobago in September 2021. The below table and chart gives further information on selectivity by value<sup>1</sup>.




