Executive Summary

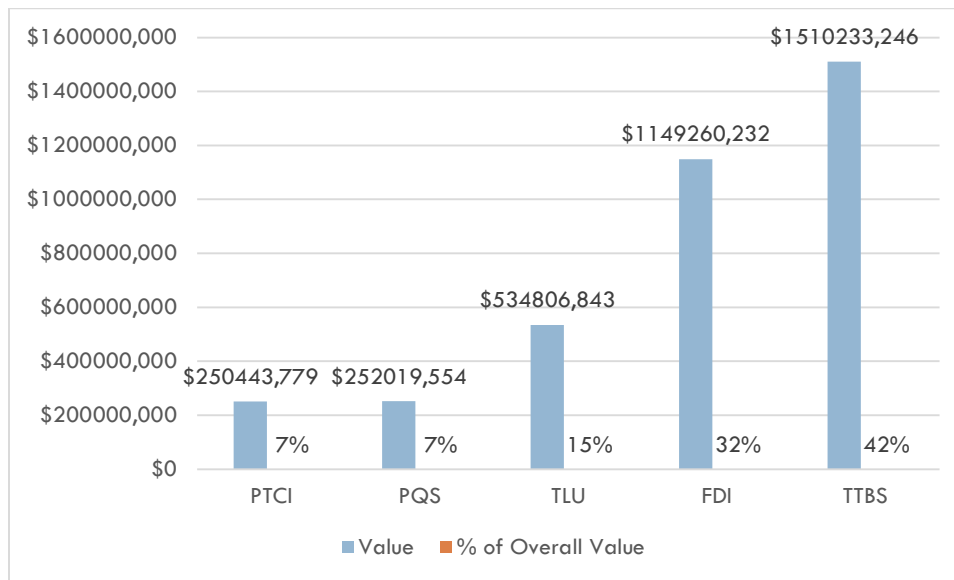
The Goods Declaration Module saw a **1.4% decrease in activity** for the month of **October 2021** when compared to the previous month, with the total declarations submitted to TTBizLink going from **11,416** to **11,252** declarations. Furthermore, there was a **15.0% decrease** in the number of declarations submitted to TTBizLink when compared to **October 2020** – where **1,612** declarations were routed to TTBizLink during that month.

The average processing time among OGAs in **October 2021** was **3.23 hours** per declaration. The average processing time of the previous month stood at 3.97 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.6 Bn** worth of goods entered Trinidad and Tobago in October 2021. The below table and chart gives further information on selectivity by value¹.

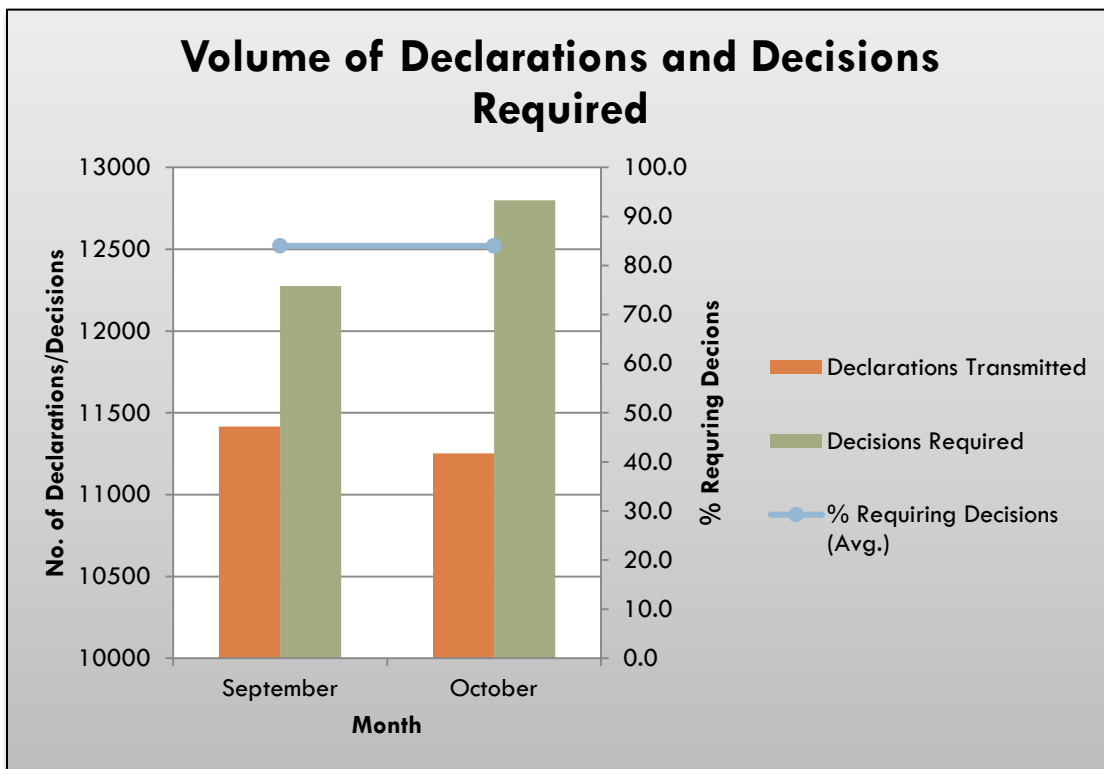

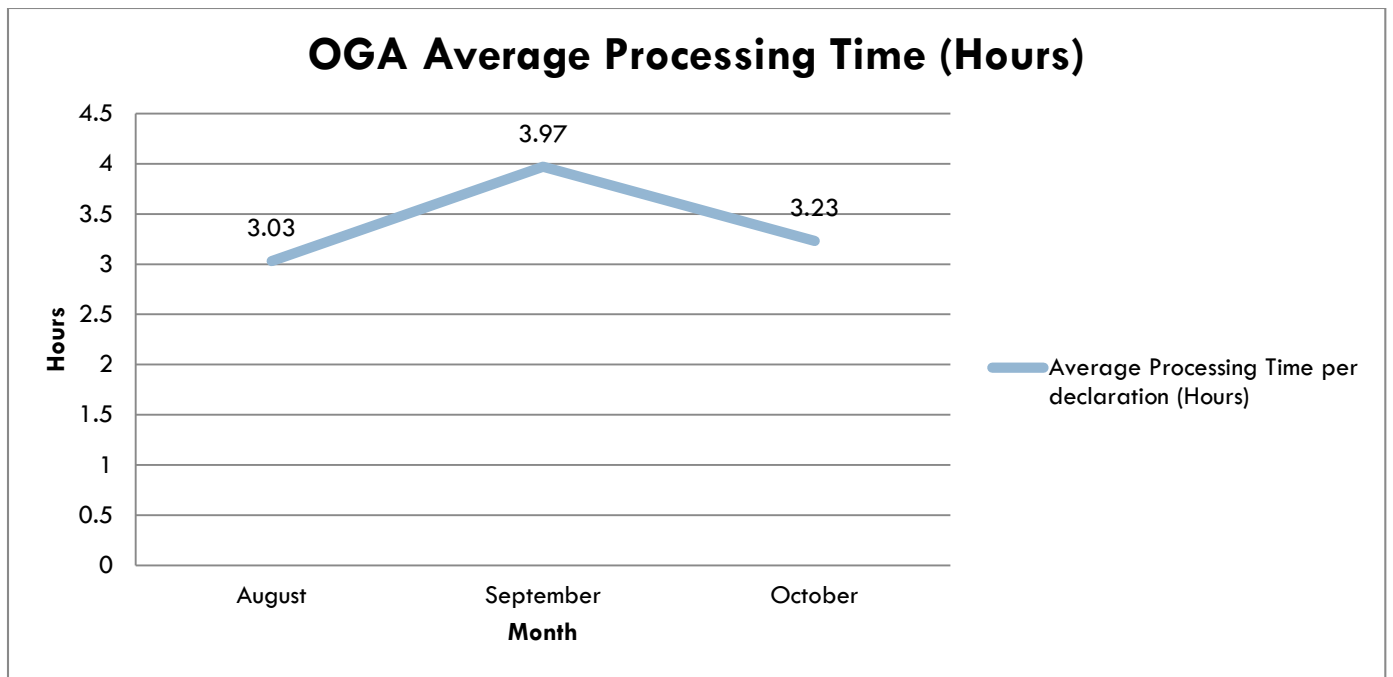
