The Chaguanas Chamber has distinguished itself as a leader in the central region, contributing positively to both the community's socio-economic recovery and broader national development. Your organization is one of the key stakeholders of the Ministry of Trade and Industry and we will continue to collaborate to develop and implement the necessary policies and programmes to build sustainable businesses and economic growth.

Government recognizes the importance of entrepreneurship and has articulated in its **National Development Strategy (NDS) for Trinidad and Tobago (2016-2030)** – **Vision 2030** the need to create a culture and climate for entrepreneurship and innovation. Guided by both Vision 2030 and the Roadmap to Recovery Report, this Government, and in particular, the Ministry of Trade and Industry is doing the necessary to ensure an enabling and entrepreneurship-friendly business environment. To achieve this, we are reforming and strengthening various state agencies, expanding funding facilities to meet the needs of

entrepreneurs of different sizes and stages of growth and focusing on implementing programmes which will aid in building capacity and globally competitive businesses in targeted sectors of economic interest.

In this regard, the Ministry of Trade and Industry through its various state agencies, in particular exporTT, offers a plethora of initiatives and programmes for Micro, Small, and Medium Enterprises (MSMEs) in what is often referred to as the Entrepreneurial Ecosystem. Some relevant initiatives include the Export Booster Initiative (EBI) which will focus on sixteen initiatives under three broad strategic areas namely Export Promotion, Capacity Building and Institutional Strengthening. Additionally, as mentioned by the Minister of Finance in the Fiscal 2022 budget, TT\$50 Mn has been allocated for the introduction of a new SME Capacity Building Programme.

This Capacity Building Programme is targeted to building SME's competency in the areas of accounting, recording keeping, training management inventory control and health and safety so that businesses are enabled to meet their statutory obligations. This Programme will strengthen the SME sector, enabling SMEs to overcome administrative and financial difficulties they often face and in particular migrate into the formal economy.

The entreprenuerial ecosystem will allow the Government to ensure that the necessary policies and programmes are tailored to meet the financial and non-financial needs of MSMEs. This is where you, the Chamber, will have a critical role to play. In order to make this entrepreneurial ecosystem a reality, a strong and effective public private partnership between Chambers like yourself and the Government is very much needed.

I wish to now recognize all awardees here tonight for their efforts in the areas of education, innovation, philanthropy and entrepreneurship. In particular, Ms. Raveena Basdeo for your resilience, hard work and dedication. I simply cannot imagine what it was like to switch to the virtual learning environment and still maintain the high level of focus required to excel in SEA; you are indeed an inspiration to the young, the old and especially us here tonight.

I recognize the President, the executive and the membership of the Chamber for being a pillar of strength in the Borough of Chaguanas. I assure you that Ministry of Trade and Industry will continue to collaborate with the Chamber and work towards policies that will redound to the benefit of the business community.
