### **Executive Summary**


The Goods Declaration Module saw a **10% decrease in activity** for the month of **December 2021** when compared to the previous month, with the total entries submitted to TTBizLink going from **12,360** to **11,118** declarations. Furthermore, there was a **17.1% decrease** in the number of declarations submitted to TTBizLink when compared to **December 2020** – with **13,410** declarations routed to TTBizLink during that month.

The average processing time among OGAs in **December 2021** was **4.13 hours** per declaration. The average processing time of the previous month stood at 3.62 hours per declaration.

#### TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.42 Bn** worth of goods entered Trinidad and Tobago in December 2021. The below table and chart gives further information on selectivity by value<sup>1</sup>.




