Executive Summary

The Goods Declaration Module saw a 13.7% increase in activity for the month of March 2022 when compared to the previous month, with the total entries submitted to TTBizLink going from 9,816 to 11,156 declarations. Furthermore, there was a 10.9% increase in the number of declarations submitted to TTBizLink when compared to March 2021 – with 10,058 declarations routed to TTBizLink during that month.

The average processing time among OGAs in **March 2022** was **4.20 hours** per declaration. The average processing time of the previous month stood at 3.07 hours per declaration.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.89 Bn** worth of goods entered Trinidad and Tobago in March 2022. The below table and chart gives further information on selectivity by value¹.





Table and Chart Demonstrating OGA Selectivity by Value


