## Executive Summary

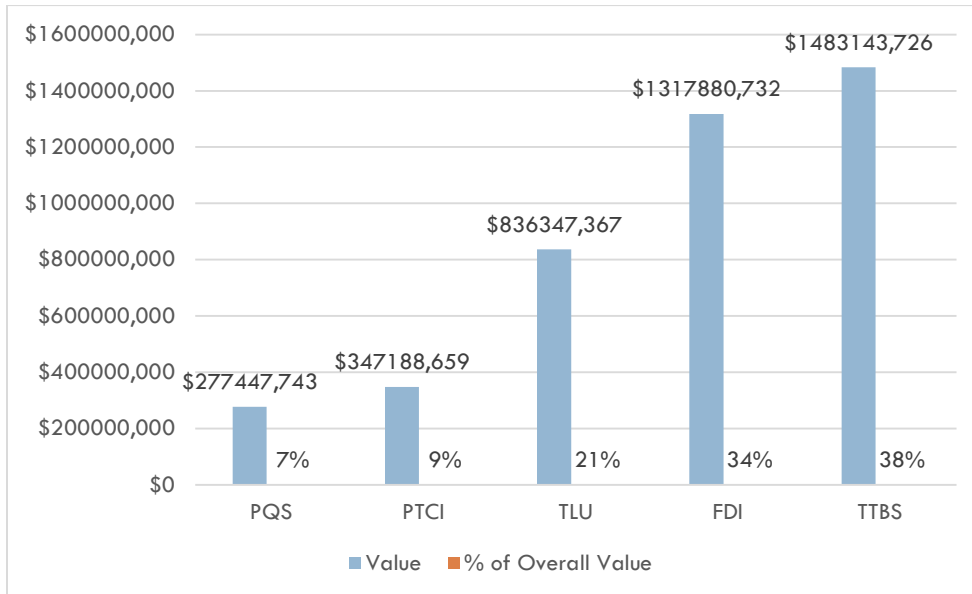
The Goods Declaration Module saw a **13.7% increase in activity** for the month of **March 2022** when compared to the previous month, with the total entries submitted to TTBizLink going from **9,816** to **11,156** declarations. Furthermore, there was a **10.9% increase** in the number of declarations submitted to TTBizLink when compared to **March 2021** – with **10,058** declarations routed to TTBizLink during that month.

The average processing time among OGAs in **March 2022** was **4.20 hours** per declaration. The average processing time of the previous month stood at 3.07 hours per declaration.

## TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.89 Bn** worth of goods entered Trinidad and Tobago in March 2022. The below table and chart gives further information on selectivity by value<sup>1</sup>.

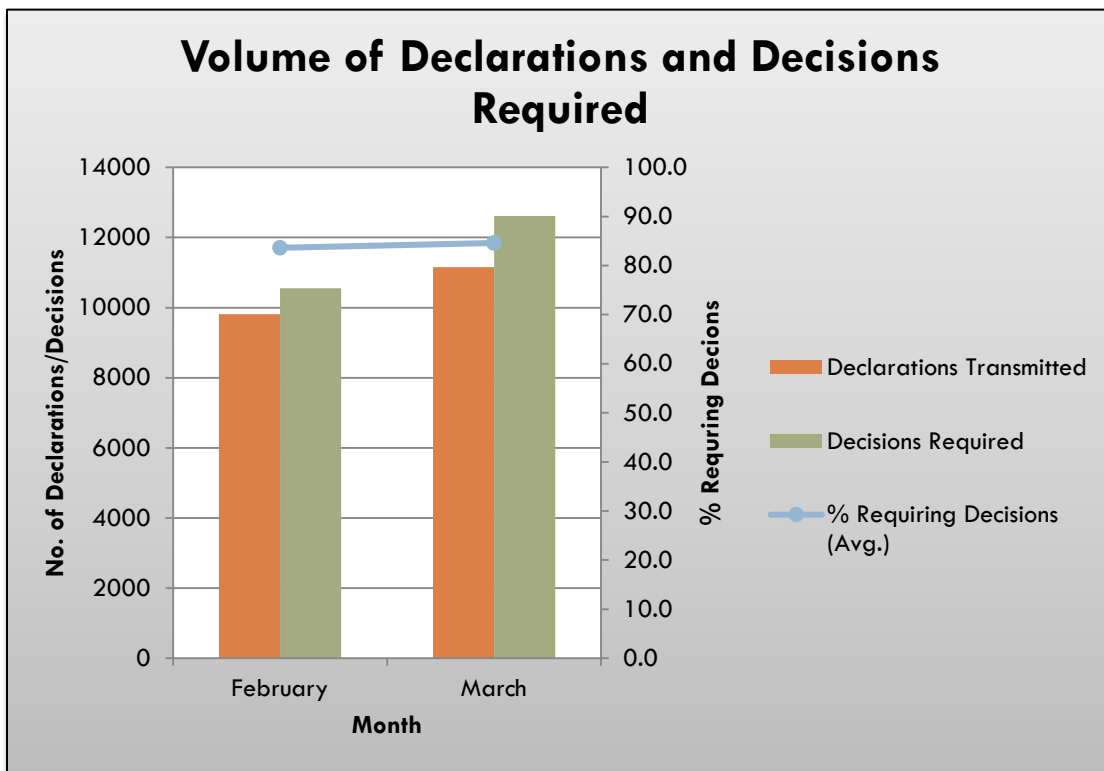


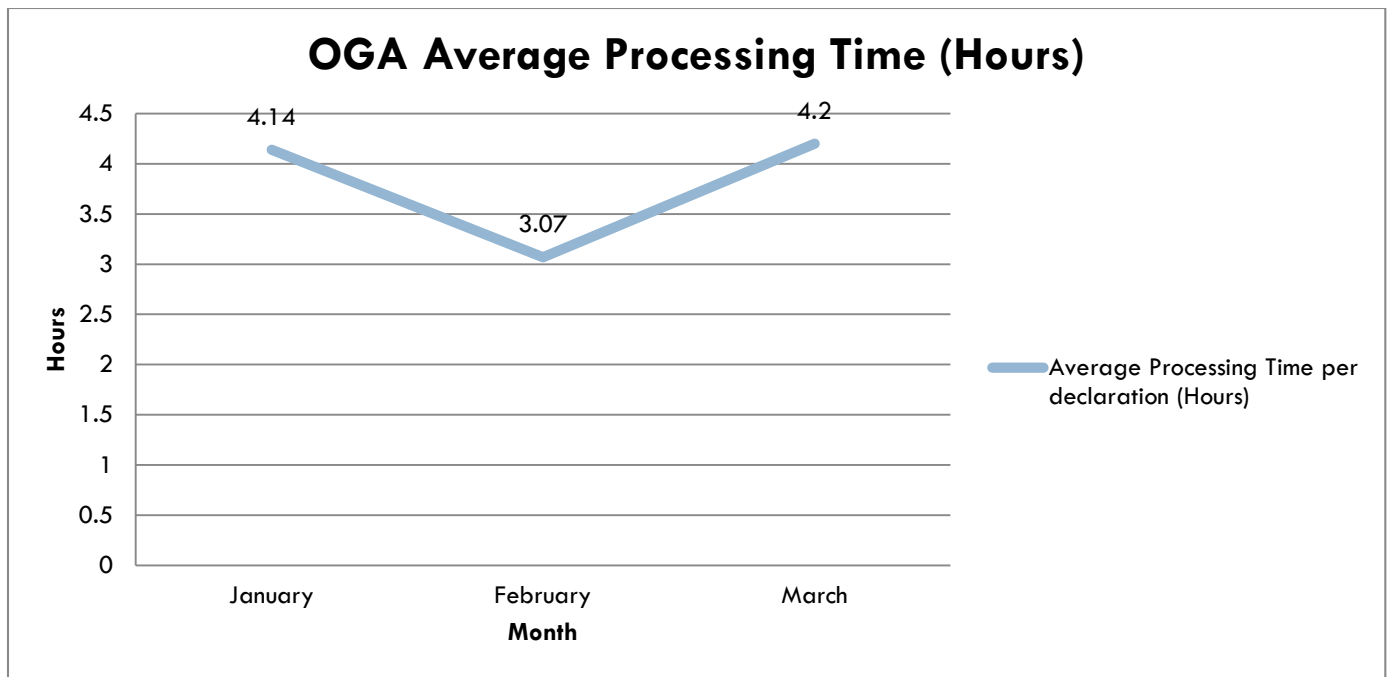
