Executive Summary

The Goods Declaration Module saw a **0.7% decrease in activity** for the month of **February 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **10,497 to 10,426** declarations. Furthermore, there was an **0.14% increase** in the number of declarations submitted to TTBizLink when compared to **February 2023** – with 9,116 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **February 2024** was **16.29 hours** per declaration. The average processing time of the previous month stood at 12.58 hours per declaration.

The decrease in processing efficiency could be attributed to an interconnectivity issue faced at the end of the month with Customs which affected regular service delivery. Customs performed a restart on their system which allowed their queue of entries to reach TTBizLink. The queue of entries took some days to all be triggered to TTBizLink and caused a surplus of entries being received for agency processing during this period.

TT\$ Value of Declarations Routed to Each Agency

A total of TT\$3.95 Bn worth of goods entered Trinidad and Tobago in February 2024.






