#### **Executive Summary**

The Goods Declaration Module saw a **1.8% decrease in activity** for the month of **March 2024** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **10,426 to 10,241** declarations. Furthermore, there was an **0.94% decrease** in the number of declarations submitted to TTBizLink when compared to **March 2023** – with 10,338 Customs Entries routed to TTBizLink during that month.

The average processing time among OGAs in **March 2024** was **13.98 hours** per declaration. The average processing time of the previous month stood at 16.29 hours per declaration.


At the end of the month, Customs experienced issues on their system which affected the rate at which entries were being received on TTBizLink. After resolving the issue, Customs retriggered these entries which all successfully reached TTBizLink.

### TT\$ Value of Declarations Routed to Each Agency

A total of TT\$3.87 Bn worth of goods entered Trinidad and Tobago in March 2024.





