Executive Summary

The Goods Declaration Module saw a **6% increase in activity** for the month of **October 2025** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **11,532 to 12,226** declarations. Furthermore, there was an **3.6% increase** in the number of declarations submitted to TTBizLink when compared to **October 2024** – with 11,801 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **October 2025** was **16.39 hours**. This is below the average processing time for the previous month which was 17.73 hours.

Upon further analysis, this decrease in processing time is associated with the more efficient processing by Plant Quarantine Services (PQS), going 45.4 hours last month to 26.9 hours this month.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$7.7 Bn** worth of goods entered Trinidad and Tobago in October 2025. The below table and chart gives further information on selectivity by value¹.





Table and Chart Demonstrating OGA Selectivity by Value


