Executive Summary

The Goods Declaration Module saw a **4.6% decrease in activity** for the month of **February 2026** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **9,212 to 8,792** declarations. Furthermore, there was an **10.2% decrease** in the number of declarations submitted to TTBizLink when compared to **February 2025** – with 9,791 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **February 2026** was **10.56 hours**. This is below the average processing time for the previous month which was 10.70 hours.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.2 Bn** worth of goods entered Trinidad and Tobago in February 2026. The below table and chart gives further information on selectivity by value¹.





Table and Chart Demonstrating OGA Selectivity by Value


