Executive Summary

The Goods Declaration Module saw a **11.3% decrease in activity** for the month of **January 2026** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **10,386 to 9,212** declarations. Furthermore, there was an **15.6% decrease** in the number of declarations submitted to TTBizLink when compared to **January 2025** – with 10,911 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **January 2026** was **10.70 hours**. This is below the average processing time for the previous month which was 16.28 hours.

The brokerage community continues to share that a decrease in imports is being observed by the importers.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$5.2 Bn** worth of goods entered Trinidad and Tobago in January 2026.

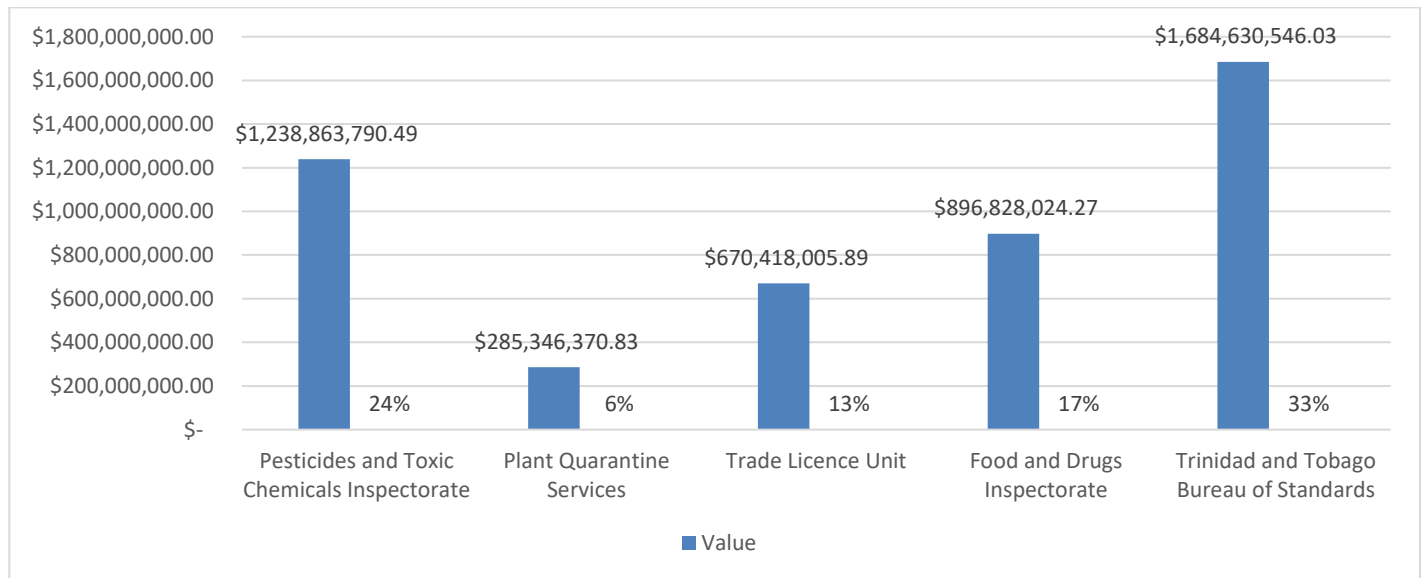


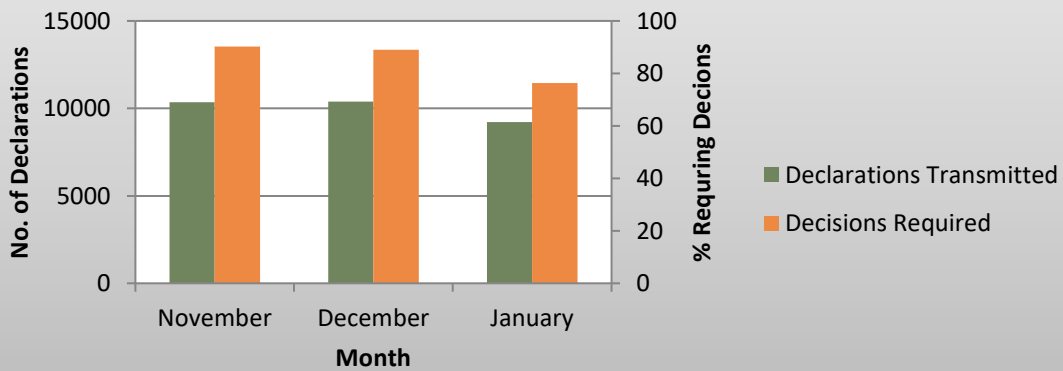
Table and Chart Demonstrating OGA Selectivity by Value

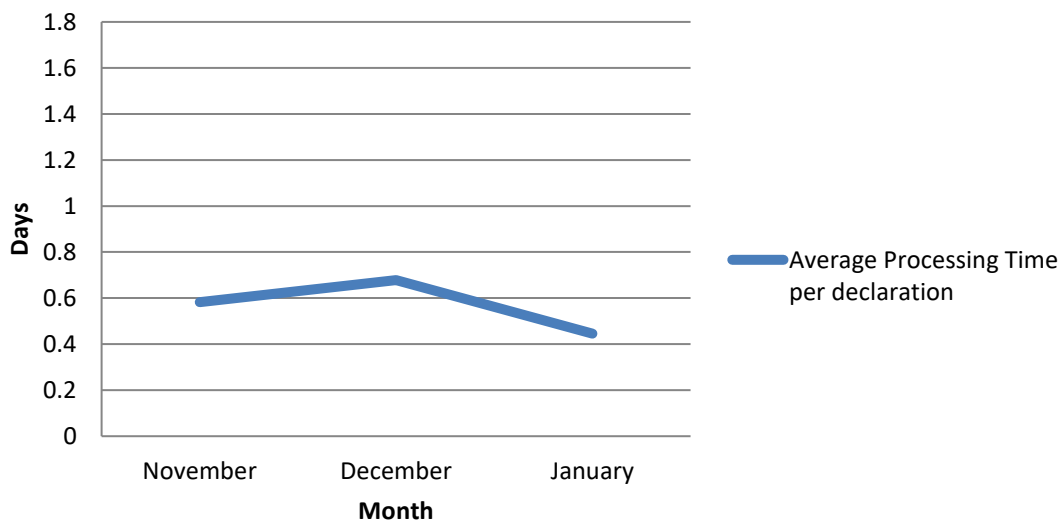
