Executive Summary

The Goods Declaration Module saw an **8.5% increase in activity** for the month of **March 2026** when compared to the previous month, with the total volume of entries submitted to TTBizLink going from **8,792 to 9,542** declarations. Furthermore, there was a **0.2% decrease** in the number of declarations submitted to TTBizLink when compared to **March 2025** – with 9,558 Customs Entries routed to TTBizLink during that month. The average processing time among OGAs in **March 2026** was **17.54 hours**. This is above the average processing time for the previous month which was 10.56 hours.

TT\$ Value of Declarations Routed to Each Agency

A total of **TT\$3.6 Bn** worth of goods entered Trinidad and Tobago in March 2026. The below table and chart gives further information on selectivity by value¹.

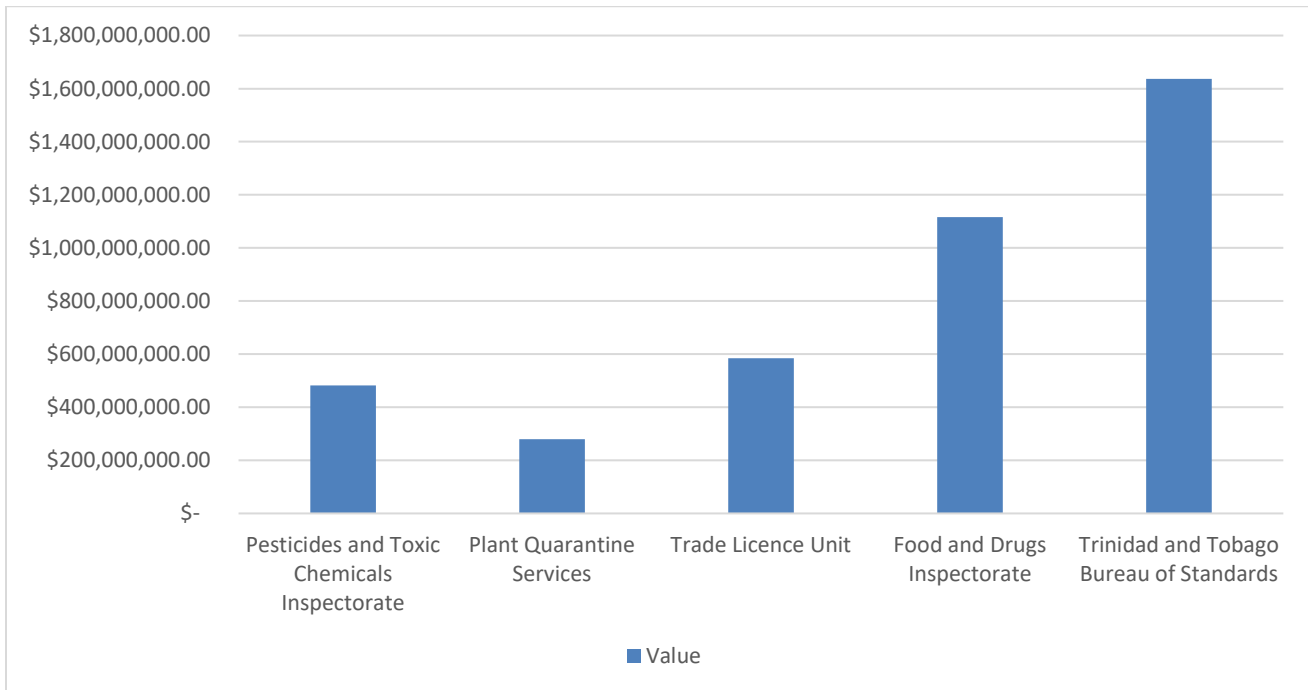


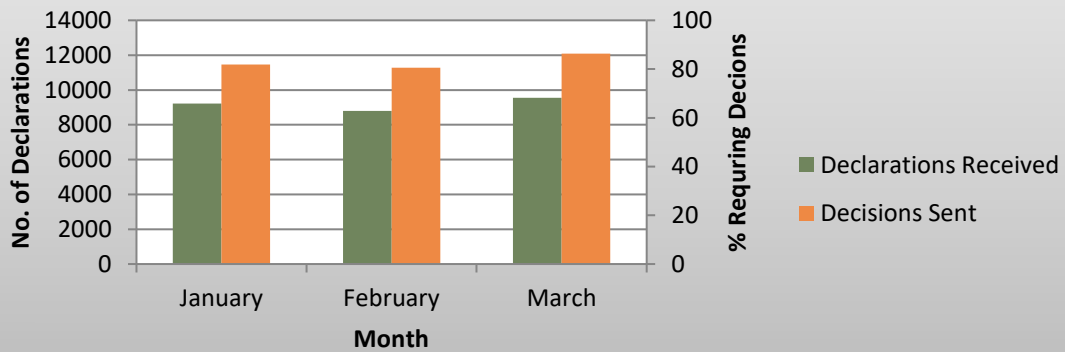
Table and Chart Demonstrating OGA Selectivity by Value

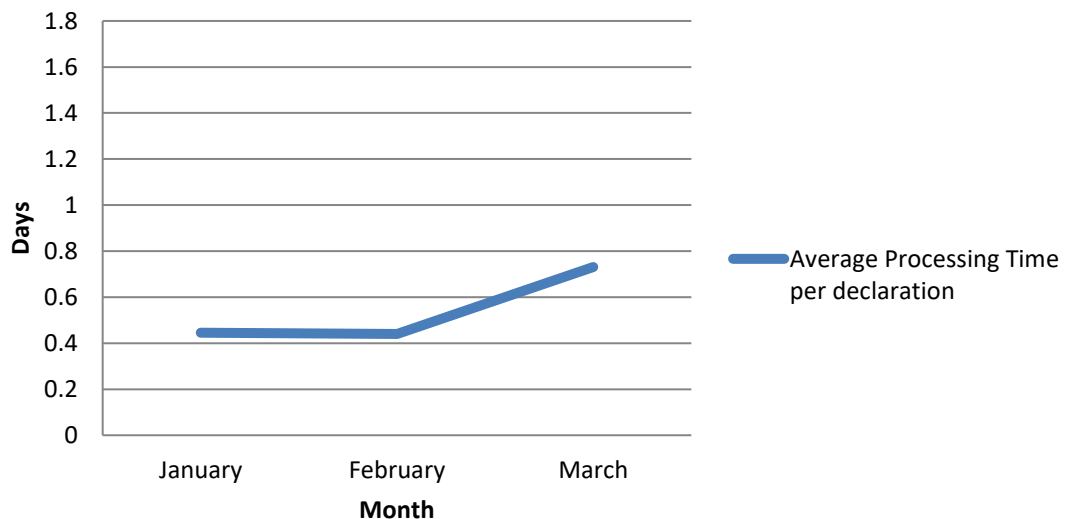
